- FOR AN ACT relating to appropriations; to appropriate funds to aid in carrying out the provisions of Legislative Bill 1014, One Hundredth Legislature, Second Session, 2008; to reduce an appropriation; and to declare an emergency.
- Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$34,724 from

- 2 the General Fund for FY2008-09 and (2) \$31,724 from the General
- 3 Fund for FY2009-10 to the Supreme Court, for Program 52, to aid in
- 4 carrying out the provisions of Legislative Bill 1014, One Hundredth
- 5 Legislature, Second Session, 2008.
- 6 Total expenditures for permanent and temporary salaries
- 7 and per diems from funds appropriated in this section shall not
- 8 exceed \$18,453 for FY2008-09 or \$18,453 for FY2009-10.
- 9 Sec. 2. There is hereby appropriated \$7,500 from the
- 10 Supreme Court Automation Cash Fund for FY2008-09 to the Supreme
- 11 Court, for Program 570, to aid in carrying out the provisions of
- 12 Legislative Bill 1014, One Hundredth Legislature, Second Session,
- 13 2008.
- 14 No expenditures for permanent and temporary salaries and
- 15 per diems for state employees shall be made from funds appropriated
- 16 <u>in this section.</u>
- Sec. 3. There is hereby appropriated (1) \$6,000 from the
- 18 Commission on Public Advocacy Operations Cash Fund for FY2008-09
- 19 and (2) \$1,000 from the Commission on Public Advocacy Operations
- 20 Cash Fund for FY2009-10 to the Commission on Public Advocacy, for
- 21 Program 425, to aid in carrying out the provisions of Legislative
- 22 Bill 1014, One Hundredth Legislature, Second Session, 2008.
- No expenditures for permanent and temporary salaries and
- 24 per diems for state employees shall be made from funds appropriated
- 25 in this section.

Sec. 4. The General Fund appropriation for FY2008-09 to

- 3 hereby reduced by \$48,893.
- 4 Total expenditures for permanent and temporary salaries

- 6 Sec. 5. Since an emergency exists, this act takes effect
- 7 when passed and approved according to law.
