- FOR AN ACT relating to the Political Subdivisions Tort Claims

 Act; to amend sections 13-919 and 13-920, Reissue Revised

 Statutes of Nebraska; to change limitation of action

 provisions; and to repeal the original sections.
- Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 13-919, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 13-919 (1) Every claim against a political subdivision
- 4 permitted under the Political Subdivisions Tort Claims Act shall be
- 5 forever barred unless within one year two years after such claim
- 6 accrued the claim is made in writing to the governing body. Except
- 7 as otherwise provided in this section, all suits permitted by the
- 8 act shall be forever barred unless begun within two years after
- 9 such claim accrued. The time to begin a suit shall be extended
- 10 for a period of six months from the date of mailing of notice to
- 11 the claimant by the governing body as to the final disposition of
- 12 the claim or from the date of withdrawal of the claim from the
- 13 governing body under section 13-906 if the time to begin suit would
- 14 otherwise expire before the end of such period.
- 15 (2) If a claim is made or filed under any other law of
- 16 this state and a determination is made by a political subdivision
- 17 or court that the act provides the exclusive remedy for the claim,
- 18 the time to make a claim and to begin suit under the act shall
- 19 be extended for a period of six months from the date of the court
- 20 order making such determination or the date of mailing of notice to
- 21 the claimant of such determination by the political subdivision if
- 22 the time to make the claim and to begin suit under the act would
- 23 otherwise expire before the end of such period. The time to begin
- 24 suit may be further extended as provided in subsection (1) of this
- 25 section.

1 (3) If a claim is made or a suit is begun under the act

- 2 and a determination is made by the political subdivision or by the
- 3 court that the claim or suit is not permitted under the act for
- 4 any other reason than lapse of time, the time to make a claim or
- 5 to begin a suit under any other applicable law of this state shall
- 6 be extended for a period of six months from the date of the court
- 7 order making such determination or the date of mailing of notice to
- 8 the claimant of such determination by the political subdivision if
- 9 the time to make the claim or begin the suit under such other law
- 10 would otherwise expire before the end of such period.
- 11 (4) If a claim is brought under the Nebraska
- 12 Hospital-Medical Liability Act, the filing of a request for review
- 13 under section 44-2840 shall extend the time to begin suit under the
- 14 Political Subdivisions Tort Claims Act an additional ninety days
- 15 following the issuance of the opinion by the medical review panel
- 16 if the time to begin suit under the Political Subdivisions Tort
- 17 Claims Act would otherwise expire before the end of such ninety-day
- 18 period.
- 19 (5) This section and section 25-213 shall be the only
- 20 statutes of limitations applicable to tort claims as defined in the
- 21 act.
- 22 Sec. 2. Section 13-920, Reissue Revised Statutes of
- 23 Nebraska, is amended to read:
- 24 13-920 (1) No suit shall be commenced against any
- 25 employee of a political subdivision for money on account of

1 damage to or loss of property or personal injury to or the death

- 2 of any person caused by any negligent or wrongful act or omission
- 3 of the employee while acting in the scope of his or her office
- 4 or employment occurring after May 13, 1987, unless a claim has
- 5 been submitted in writing to the governing body of the political
- 6 subdivision within one year two years after such claim accrued in
- 7 accordance with section 13-905.
- 8 (2) No suit shall be permitted on a claim filed pursuant
- 9 to this section unless the governing body of the political
- 10 subdivision has made final disposition of the claim, except that
- 11 if the governing body does not make final disposition of the claim
- 12 within six months after the claim is filed, the claimant may, by
- 13 notice in writing, withdraw the claim from consideration of the
- 14 governing body and begin suit.
- 15 (3) Except as provided in section 13-919, any suit
- 16 commenced on any claim filed pursuant to this section shall be
- 17 forever barred unless begun within two years after the claim
- 18 accrued. The time to begin suit under this section shall be
- 19 extended for a period of six months (a) from the date of mailing
- 20 of notice to the claimant by the governing body as to the final
- 21 disposition of the claim or (b) from the date of withdrawal of the
- 22 claim from the governing body under this section, if the time to
- 23 begin suit would otherwise expire before the end of such period.
