LEGISLATIVE BILL 377A

Approved by the Governor May 30, 2007

Introduced by Ashford, 20

FOR AN ACT relating to appropriations; to appropriate funds to aid in carrying out the provisions of Legislative Bill 377, One Hundredth Legislature, First Session, 2007; and to declare an emergency.

Be it enacted by the people of the State of Nebraska,

Section 1. There is hereby appropriated (1) \$31,528 from the General Fund for FY2007-08 and (2) \$64,159 from the General Fund for FY2008-09 to the Supreme Court, for Program 3, to aid in carrying out the provisions of Legislative Bill 377, One Hundredth Legislature, First Session, 2007.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$31,077 for FY2007-08 or \$63,242 for FY2008-09.

Sec. 2. There is hereby appropriated (1) \$25,675 from the General Fund for FY2007-08 and (2) \$52,245 from the General Fund for FY2008-09 to the Supreme Court, for Program 4, to aid in carrying out the provisions of Legislative Bill 377, One Hundredth Legislature, First Session, 2007.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$25,308 for FY2007-08 or \$51,498 for FY2008-09.

Sec. 3. <u>There is hereby appropriated (1) \$274,992 from the General</u> Fund for FY2007-08 and (2) \$559,560 from the General Fund for FY2008-09 to the Supreme Court, for Program 6, to aid in carrying out the provisions of Legislative Bill 377, One Hundredth Legislature, First Session, 2007.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$271,062 for FY2007-08 or \$551,562 for FY2008-09.

Sec. 4. There is hereby appropriated (1) \$235,129 from the General Fund for FY2007-08 and (2) \$478,436 from the General Fund for FY2008-09 to the Supreme Court, for Program 7, to aid in carrying out the provisions of Legislative Bill 377, One Hundredth Legislature, First Session, 2007.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$231,768 for FY2007-08 or \$471,598 for FY2008-09.

Sec. 5. There is hereby appropriated (1) \$66,377 from the General Fund for FY2007-08 and \$2,500 from the Supreme Court Education Fund for FY2007-08 and (2) \$66,377 from the General Fund for FY2008-09 to the Supreme Court, for Program 52, to aid in carrying out the provisions of Legislative Bill 377, One Hundredth Legislature, First Session, 2007.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$47,653 for FY2007-08 or \$47,653 for FY2008-09.

Sec. 6. <u>There is hereby appropriated (1) \$29,166 from the</u> <u>Compensation Court Cash Fund for FY2007-08 and (2) \$59,347 from the</u> <u>Compensation Court Cash Fund for FY2008-09 to the Nebraska Workers'</u> <u>Compensation Court, for Program 526, to aid in carrying out the provisions of</u> <u>Legislative Bill 377, One Hundredth Legislature, First Session, 2007.</u>

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$28,749 for FY2007-08 or \$58,499 for FY2008-09.

Sec. 7. Since an emergency exists, this act takes effect when passed and approved according to law.
