Summary of purpose and/or changes:

Under current law, a keno operator must wait 5 minutes after the conclusion of the previous game before the next game can start. LB 490 would set the time requirement between games at 1 minute, but the local political subdivision could increase the time requirement to any time longer than 1 minute. LB 490 also eliminates the requirement for an attendant to write the keno tickets.

LB 490 is tied to LB 681 in the sense that if LB 490 were to increase keno tax revenue, then LB 681 would credit a portion of that increase to the Live Horseracing Endowment Fund that is created in LB 681. Currently, the keno tax revenue is averaging approximately \$4 million.

Explanation of amendments:

The committee amendment creates the Live Horseracing Endowment Fund found in LB 681. Five percent of the fund may be used for administrative costs and the remainder of the fund is to be used for thoroughbred horseracing purses. The State of Nebraska would receive annually the first \$4 million of keno tax revenue and any additional revenue would be divided with 50 percent being credited to the Charitable Gaming Operations Fund and 50 percent being credited to the Live Horseracing Endowment Fund. LB 490 originally reduced the time between keno games from 5 minutes to 1 minute unless the local municipality chose a time greater than 1 minute. The committee amendment eliminates this provision, leaving the minimum time required between keno games at 5 minutes.
