## A BILL

1	FOR AN ACT	relating to the Game Law; to amend sections 37-238,
2		37-405, 37-420, 37-421, 37-421.01, 37-427, 37-461,
3		37-464, 37-483, 37-484, 37-485, 37-487, 37-488, 37-489,
4		37-490, 37-492, 37-497, 37-498, 37-4,103, 37-503, and
5		37-512, Reissue Revised Statutes of Nebraska, and
6		sections 37-327, 37-407, 37-411, 37-426, 37-431, and
7		37-450, Revised Statutes Cumulative Supplement, 2010; to
8		change and eliminate provisions relating to fees,
9		falconry, beaver and muskrat damage, controlled shooting
10		areas, and possession of game; to change and eliminate
11		provisions relating to licenses, permits, and stamps
12		issued under the Game Law; to harmonize provisions; to
13		repeal the original sections; and to outright repeal
14		sections 37-460, 37-499, 37-4,100, 37-4,101, 37-4,102,
15		and 37-562, Reissue Revised Statutes of Nebraska.

Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 37-238, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 37-238 Raptor means any bird of the Accipitriformes,
- 4 Falconiformes, or Strigiformes, except the golden and bald eagles.
- 5 including, but not limited to, caracaras, eagles, falcons, harriers,
- 6 hawks, kites, osprey, owls, and vultures.
- 7 Sec. 2. Section 37-327, Revised Statutes Cumulative
- 8 Supplement, 2010, is amended to read:
- 9 37-327 (1) The commission shall establish fees for
- 10 licenses, permits, stamps, bands, registrations, and certificates
- 11 issued under the Game Law and the State Boat Act and shall establish
- 12 the fee required by section 37-562 as provided in such law, act, and
- 13 section. the Game Law and State Boat Act. The commission shall not
- 14 increase any fee more than six percent per year, except that if a fee
- 15 has not been increased by such percentage in the immediately
- 16 preceding year, the difference between a six percent increase and the
- 17 actual percentage increase in such preceding year may be added to the
- 18 percentage increase in the following year. Such fees shall be
- 19 collected and disposed of as provided in such law, act, and section.
- 20 <u>the Game Law and State Boat Act.</u> The commission shall, as provided in
- 21 such law, act, and section, the Game Law and State Boat Act,
- 22 establish issuance fees to be retained by authorized agents of
- 23 <u>issuing</u> such licenses, permits, stamps, bands, registrations, and
- 24 certificates. under such law, act, and section. The commission shall
- 25 establish such fees by the adoption and promulgation of rules and

- 1 regulations.
- 2 (2) Prior to establishing any fee, the commission shall,
- 3 at least thirty days prior to the hearing required in section 84-907,
- 4 make the following information available for public review:
- 5 (a) The commission's policy on the minimum cash balance
- 6 to be maintained in the fund in which the revenue from the fee being
- 7 established is deposited and the justification in support of such
- 8 policy;
- 9 (b) Monthly estimates of cash fund revenue, expenditures,
- 10 and ending balances for the current fiscal year and the following two
- 11 fiscal years for the fund in which the revenue from the fee being
- 12 established is deposited. Estimates shall be prepared for both the
- 13 current fee schedule and the proposed fee schedule; and
- 14 (c) A statement of the reasons for establishing the fee
- 15 at the proposed level.
- 16 (3) The commission may adopt and promulgate rules and
- 17 regulations to establish fees for expired licenses, permits, stamps,
- 18 bands, registrations, and certificates issued under the Game Law and
- 19 the State Boat Act. The commission shall collect the fees and remit
- 20 them to the State Treasurer for credit to the State Game Fund.
- 21 Sec. 3. Section 37-405, Reissue Revised Statutes of
- 22 Nebraska, is amended to read:
- 23 37-405 (1) The commission shall provide for the issuance
- 24 of permits to hunt, fish, or harvest fur. Application for such
- 25 permits shall be made to the commission or its agents and shall

1 contain such information as may be prescribed by the commission. All

- 2 applications for permits to harvest fur shall include the applicant's
- 3 social security number. A permit shall authorize the person to whom
- 4 it is issued to hunt, fish, or harvest fur-bearing animals as
- 5 provided by the Game Law during the period for which the permit is
- 6 issued.
- 7 (2) If the holder of a hunting permit is a hunter of
- 8 migratory game birds, he or she shall be required to declare himself
- 9 or herself as such and provide information regarding his or her
- 10 migratory game bird hunting activity to the commission. Documentation
- 11 of such a declaration shall be made on the hunting permit or a
- 12 separate document which shall become a part of the permit. Costs to
- 13 the commission of implementing such declaration and documentation and
- 14 for participation in a federal program designed to obtain survey
- 15 information on migratory bird hunting activity shall be funded from
- 16 the State Game Fund. For purposes of this subsection, migratory bird
- 17 has the definition found in 50 C.F.R. part 10, subpart B, section
- 18 10.12, and migratory game bird has the definition found in 50 C.F.R.
- 19 part 20, subpart B, section 20.11(a).
- 20  $\frac{(3)}{(3)}$  All permits shall expire at midnight on
- 21 December 31 in the year for which the permit is issued, except as
- 22 otherwise provided in subdivision (b) of this subsection and sections
- 23 37-415, 37-420, and 37-421.
- 24 (b) The commission may issue multiple-year permits to
- 25 hunt, fish, or harvest fur. The permits shall expire at midnight on

- 1 December 31 in the last year for which the permit is valid.
- 2 (c) A multiple-year permit issued to a resident of
- 3 Nebraska shall not be made invalid by reason of the holder
- 4 subsequently residing outside of Nebraska.
- 5 (4) A person who is hunting, fur harvesting, or fishing
- 6 shall present evidence of having a permit immediately upon demand to
- 7 any officer or person whose duty it is to enforce the Game Law. Any
- 8 person hunting, fishing, or fur harvesting in this state without such
- 9 evidence shall be deemed to be without such permit.
- 10 (5) The commission shall adopt and promulgate rules and
- 11 regulations necessary to carry out this section.
- 12 Sec. 4. Section 37-407, Revised Statutes Cumulative
- 13 Supplement, 2010, is amended to read:
- 14 37-407 The commission may offer multiple-year permits or
- 15 combinations of permits at reduced rates and may establish fees
- 16 pursuant to section 37-327 to be paid to the state for resident and
- 17 nonresident hunting permits, annual fishing permits, three-day
- 18 fishing permits, one-day fishing permits, combination hunting and
- 19 fishing permits, fur-harvesting permits, and nonresident special two-
- 20 day hunting permits, issued for periods of two consecutive days
- 21 between the Wednesday immediately preceding Thanksgiving Day and
- 22 December 31 of the same calendar year and limited to one special two-
- 23 day permit per applicant per year, as follows:
- 24 (1) Resident fees shall be (a) not more than thirteen

1 37-411 (1) Unless issued a permit as required in the Game

- 2 Law, it shall be unlawful:
- 3 (a) For any resident of Nebraska who is sixteen years of

- 5 harvesting or possess any fur-bearing animal or raw fur. , except
- 6 that a person may possess a fur-bearing animal or raw fur for up to
- 7 ten days after expiration of a valid permit. Nonresident fur-
- 8 harvesting permits may be issued only to residents of states which
- 9 issue similar permits to residents of Nebraska;
- 10 (b) For any resident of Nebraska who is sixteen years of
- 11 age or older or any nonresident of Nebraska to hunt or possess any
- 12 kind of game birds, game animals, or crows;
- 13 (c) For any person who is sixteen years of age or older
- 14 to hunt or possess any migratory waterfowl without a federal
- 15 migratory bird hunting stamp and a Nebraska migratory waterfowl stamp

- 19 to take any kind of fish, bullfrog, snapping turtle, tiger

- 6 lifetime fishing permits or lifetime combination hunting and fishing
- 7 permits purchased prior to January 1, 2006. Nebraska migratory
- 8 waterfowl stamps are not required for hunting, harvesting, or
