## A BILL

1	FOR AN ACT :	relating to appropriations; to appropriate funds to aid in
2		carrying out the provisions of Legislative Bill 463, One
3		Hundred Second Legislature, First Session, 2011; to
4		reduce an appropriation; to state intent; and to declare
5		an emergency.

6 Be it enacted by the people of the State of Nebraska,

1	Section 1. There is hereby appropriated (1) \$100,000 from
2	the Court Appointed Special Advocate Fund for FY2011-12 and (2)
3	\$200,000 from the Court Appointed Special Advocate Fund for FY2012-13
4	to the Supreme Court, for Program 52, to aid in carrying out the
5	provisions of Legislative Bill 463, One Hundred Second Legislature,
6	<u>First Session, 2011.</u>
7	There is included in the appropriation to this program
8	for FY2011-12 \$90,000 cash funds for state aid, which shall only be
9	used for such purpose. There is included in the appropriation to this
10	program for FY2012-13 \$190,000 cash funds for state aid, which shall
11	only be used for such purpose.
12	Total expenditures for permanent and temporary salaries
13	and per diems from funds appropriated in this section shall not
14	exceed \$10,000 for FY2011-12 or \$10,000 for FY2012-13.
15	Sec. 2. The appropriation to the State Department of
16	Education, for Program 158, is hereby reduced by \$150,000 General
17	Funds for FY2011-12 and by \$30,000 General Funds for FY2012-13, to
18	aid in carrying out the provisions of Legislative Bill 463, One
19	Hundred Second Legislature, First Session, 2011.
20	It is the intent of the Legislature that the reductions
21	contained in this section shall reduce the amount allocated as state
22	aid for learning community aid by \$150,000 General Funds for
23	FY2011-12 and by \$30,000 General Funds for FY2012-13.
24	Sec. 3. There is hereby appropriated (1) \$150,000 from
25	the General Fund for FY2011-12 and (2) \$30,000 from the General Fund

1	for FY2012-13 to the Nebraska Commission on Law Enforcement and
2	Criminal Justice, for Program 215, to aid in carrying out the
3	provisions of Legislative Bill 463, One Hundred Second Legislature,
4	<u>First Session, 2011.</u>
5	No expenditures for permanent and temporary salaries and
6	per diems for state employees shall be made from funds appropriated
7	in this section.
8	Sec. 4. Since an emergency exists, this act takes effect
9	when passed and approved according to law.
