1	FOR AN ACT relating to the Game and Parks Commission;	to amend
2	section 37-354, Revised Statutes Supplement,	2011; to
3	authorize the commission to convey certain real	estate;
4	to prescribe conditions relating to the cor	ıveyance,
5	operation, and maintenance of the real estate; to	provide
6	duties for the commission; to harmonize provis	ions; to
7	repeal the original section; and to declare an en	nergency.
8	Be it enacted by the people of the State of Nebraska,	

1. (1) The Game and Parks Commission is 1 2 authorized to convey to the county of Chase for public purposes the 3 following described real estate, now known as Champion Mill State 4 Historical Park, situated in the county of Chase, in the State of 5 Nebraska, to-wit: All of block 4, original town of Champion, Nebraska, and lots 1, 2, and 3, lot 4 except commencing at the 6 7 southwest corner of lot 4 in block 5 of the original town of Champion, Nebraska, said point of beginning being at the point of 8 intersection of the north property line of Second Street and the east 9 10 line of the alley in said block 5; thence running north along the west line of said lot 4 a distance of 70 feet; thence running east 75 11 12 feet parallel with the south line of said lot 4; thence south 13 parallel with the west line of lot 4 a distance of 70 feet to intersect the south line of said lot 4; thence west along the south 14 line of said lot 4 a distance of 75 feet to the place of beginning, 15 16 the north half of lot 9, and all of lots 10, 11, 12, and 13, all in 17 block 5, original town of Champion, Nebraska. 18 (2) The Game and Parks Commission is authorized to convey to the county of Chase for public purposes the following described 19 20 real estate, now known as Champion Lake State Recreation Area, 21 situated in the county of Chase, in the State of Nebraska, to-wit: 22 (a) The following described portion of the southwest quarter of section 21, township 6 north, range 39 west of the 6th 23 principal meridian in Chase County, Nebraska, to-wit: Commencing at 24 the northeast corner of said quarter section; thence west on the 25

north line of said quarter section 1,017 feet to a stone; thence 1 2 southeasterly 992 feet in a straight line to a point on the west line 3 of the west side of block 23, West Champion, which is 102.5 feet 4 south of the northwest corner of said block 23; thence north 102.5 feet to the northwest corner of said block 23, in West Champion; 5 thence east along the north side of said block 23 and along a line 6 7 which is the north side of said block 23 produced eastward to the 8 east line of said quarter section; thence north along the east line 9 of said quarter section 644 feet to the northeast corner of said 10 quarter section; and (b) The following described property, same being a part 11 12 of the northwest quarter of the southeast quarter of section 21, 13 township 6 north, range 39 west of the 6th principal meridian in Chase County, Nebraska, to-wit: Commencing at the northwest corner of 14 the southeast quarter of section 21, township 6 north, range 39 west 15 16 of the 6th principal meridian in Chase County, Nebraska, and running 17 thence east 1,080 feet; thence south 100 feet to the north line of Fourth Street of the original town of Champion, Nebraska; thence west 18 along the said north line of Fourth Street aforesaid 1,080 feet; 19 20 thence north 100 feet to the place of beginning, said land being also 21 described as Lots 3, 4, 5, 6, 7, 8, 9, 10, and 11, Champion 22 subdivision of the northwest quarter of the southeast quarter of section 21, township 6 north, range 39 west of the 6th principal 23 meridian in Chase County, Nebraska. 24 Sec. 2. - 2 37-354 Property conveyed by the commission pursuant to
- 3 sections 90-272 to 90-275 and section 1 of this act shall be operated
- 4 and maintained as follows:
- 5 (1) The property shall be maintained so as to appear
- 6 attractive and inviting to the public;
- 7 (2) Sanitation and sanitary facilities shall be
- 8 maintained in accordance with applicable health standards;
- 9 (3) Properties shall be kept reasonably open, accessible,
- 10 and safe for public use. Fire prevention and similar activities shall
- 11 be maintained for proper public safety;
- 12 (4) Buildings, roads, trails, and other structures and
- 13 improvements shall be kept in reasonable repair throughout their
- 14 estimated lifetime to prevent undue deterioration and to encourage
- 15 public use; and
- 16 (5) The facility shall be kept open for public use at
- 17 reasonable hours and times of the year, according to the type of area
- 18 or facility.
- 19 The commission shall be responsible for compliance and
- 20 enforcement of the requirements set forth in this section.

- Sec. 4. Since an emergency exists, this act takes effect
- 24 when passed and approved according to law.
