## A BILL

1	FOR AN ACT relating to the Game and Parks Commission; to amend
2	section 37-354, Revised Statutes Supplement, 2011; to
3	authorize the commission to convey certain real estate;
4	to prescribe conditions relating to the conveyance,
5	operation, and maintenance of the real estate; to provide
6	duties for the commission; to harmonize provisions; to
7	repeal the original section; and to declare an emergency.
8	Be it enacted by the people of the State of Nebraska,

1 Section 1. The Game and Parks Commission is authorized to 2 convey to the Lower Loup Natural Resources District for public 3 purposes the following described real estate, now known as Pibel Lake 4 State Recreation Area, situated in the county of Wheeler, in the 5 State of Nebraska, to-wit: A tract of land in the southeast quarter 6 of section 25, township 21 north, range 11 west of the 6th principal 7 meridian, Wheeler County, Nebraska, more fully described as follows: 8 Commencing at the southeast corner of section 25, township 21 north, 9 range 11 west of the 6th principal meridian, (the east side of said 10 section having an assumed bearing of north 0 degrees, 00 minutes east 11 and the south side of said section an assumed bearing of south 89 12 degrees, 25 minutes west); thence south 89 degrees, 25 minutes west a 13 distance of 440 feet to the point of beginning; thence south 89 degrees, 25 minutes west a distance of 1409.85 feet; thence north 0 14 degrees, 53 minutes east a distance of 890.25 feet; thence north 89 15 degrees, 25 minutes east a distance of 396 feet; thence north 0 16 degrees, 00 minutes east a distance of 160 feet; thence north 89 17 degrees, 25 minutes east a distance of 160 feet; thence north 0 18 degrees, 00 minutes east a distance of 930 feet; thence south 89 19 20 degrees, 25 minutes west a distance of 480 feet; thence north 9 degrees, 18 minutes west a distance of 367.51 feet; thence south 79 21 22 degrees, 13 minutes east a distance of 1017.65 feet; thence south 42 degrees, 54 minutes east a distance of 220 feet; thence south 17 23 degrees, 13 minutes east a distance of 580.15 feet; thence south 0 24 25 degrees, 58 minutes west a distance of 586.0 feet; thence south 37

- 1 degrees, 44 minutes east a distance of 111.0 feet; thence south 0
- 2 degrees, 00 minutes west a distance of 750 feet to the point of
- 3 beginning; excepting lots 49, 50, 77 and 78 in the plat of Pibel
- 4 Lake, a total of 53.4 acres.
- 5 Sec. 2. Section 37-354, Revised Statutes Supplement,
- 6 2011, is amended to read:
- 7 37-354 Property conveyed by the commission pursuant to
- 8 sections 90-272 to 90-275 and section 1 of this act shall be operated
- 9 and maintained as follows:
- 10 (1) The property shall be maintained so as to appear
- 11 attractive and inviting to the public;
- 12 (2) Sanitation and sanitary facilities shall be
- 13 maintained in accordance with applicable health standards;
- 14 (3) Properties shall be kept reasonably open, accessible,
- 15 and safe for public use. Fire prevention and similar activities shall
- 16 be maintained for proper public safety;
- 17 (4) Buildings, roads, trails, and other structures and
- 18 improvements shall be kept in reasonable repair throughout their
- 19 estimated lifetime to prevent undue deterioration and to encourage
- 20 public use, including the maintenance of the area's federally funded
- 21 public boating access facilities existing on the property, which is
- 22 specially assigned and required through 2024; and
- 23 (5) The facility shall be kept open for public use at
- 24 reasonable hours and times of the year, according to the type of area
- 25 or facility.

1 The commission shall be responsible for compliance and

- 2 enforcement of the requirements set forth in this section, except
- 3 that, as to the property conveyed pursuant to section 1 of this act,
- 4 the commission shall be responsible only for enforcement of the Game
- 5  $\underline{\text{Law}}$ .
- 6 Sec. 3. Original section 37-354, Revised Statutes
- 7 Supplement, 2011, is repealed.
- 8 Sec. 4. Since an emergency exists, this act takes effect
- 9 when passed and approved according to law.
