- 1 FOR AN ACT relating to crimes and offenses; to amend section 28-1310,
- 2 Reissue Revised Statutes of Nebraska; to change
- 3 provisions and a penalty relating to intimidation by
- 4 telephone call; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 28-1310, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 28-1310 (1) A person commits the offense of intimidation
- 4 by telephone call or electronic communication device if, with intent
- 5 to terrify, intimidate, threaten, harass, annoy, or offend, the
- 6 person:
- 7 (a) <u>Telephones Contacts</u> another <u>by telephone or</u>
- 8 <u>electronic communication device</u> anonymously, whether or not
- 9 conversation ensues, and disturbs the peace, quiet, and right of
- 10 privacy of any person at the place where the calls communications are
- 11 received; or
- 12 (b) <u>Telephones Contacts</u> another <u>by telephone or</u>
- 13 <u>electronic communication device</u> and uses indecent, lewd, lascivious,
- 14 or obscene language or suggests any indecent, lewd, or lascivious
- 15 act; or
- 16 (c) Telephones Contacts another by telephone or
- 17 <u>electronic communication device</u> and threatens to inflict injury to
- 18 any person or to the property of any person; or
- 19 (d) Intentionally Contacts another by telephone or
- 20 <u>electronic communication device and intentionally</u> fails to disengage
- 21 the connection; or
- 22 (e) <u>Telephones Contacts</u> another <u>by telephone or</u>
- 23 <u>electronic communication device</u> and attempts to extort money or other
- 24 thing of value from any person.
- 25 (2) The use of indecent, lewd, or obscene language or the

1 making of a threat or lewd suggestion shall be prima facie evidence

- of intent to terrify, intimidate, threaten, harass, annoy, or offend.
- 3 (3) The offense shall be deemed to have been committed
- 4 either at the place where the call such communication was made or
- 5 where it was received.
- 6 (4) For purposes of this section, electronic
- 7 communication device means any device which, in its ordinary and
- 8 intended use, transmits by electronic means writings, sounds, visual
- 9 <u>images</u>, or data of any nature to another electronic communication
- 10 <u>device</u>.
- 11 (4) (5) Intimidation by telephone call or electronic
- 12 <u>communication device</u> is a Class <u>HII—I misdemeanor</u>.
