A BILL

1	FOR AN ACT relating to appropriations; to appropriate funds to aid in
2	carrying out the provisions of Legislative Bill 306, One
3	Hundred Third Legislature, First Session, 2013; to
4	provide an operative date; and to declare an emergency.
5	Be it enacted by the people of the State of Nebraska,

1	Section 1. There is hereby appropriated (1) \$51,704 from
2	the General Fund for FY2013-14 and (2) \$105,994 from the General Fund
3	for FY2014-15 to the Nebraska Supreme Court, for Program 3, to aid in
4	carrying out the provisions of Legislative Bill 306, One Hundred
5	<u>Third Legislature, First Session, 2013.</u>
6	Total expenditures for permanent and temporary salaries
7	and per diems from funds appropriated in this section shall not
8	exceed \$50,965 for FY2013-14 or \$104,479 for FY2014-15.
9	Sec. 2. There is hereby appropriated (1) \$42,102 from the
10	General Fund for FY2013-14 and (2) \$86,309 from the General Fund for
11	FY2014-15 to the Nebraska Supreme Court, for Program 4, to aid in
12	carrying out the provisions of Legislative Bill 306, One Hundred
13	<u>Third Legislature, First Session, 2013.</u>
14	Total expenditures for permanent and temporary salaries
15	and per diems from funds appropriated in this section shall not
16	<u>exceed \$41,500 for FY2013-14 or \$85,075 for FY2014-15.</u>
17	Sec. 3. There is hereby appropriated (1) \$457,766 from
18	the General Fund for FY2013-14 and (2) \$938,421 from the General Fund
19	for FY2014-15 to the Nebraska Supreme Court, for Program 6, to aid in
20	carrying out the provisions of Legislative Bill 306, One Hundred
21	<u>Third Legislature, First Session, 2013.</u>
22	Total expenditures for permanent and temporary salaries
23	and per diems from funds appropriated in this section shall not
24	<u>exceed \$451,224 for FY2013-14 or \$925,009 for FY2014-15.</u>
25	Sec. 4. There is hereby appropriated (1) \$385,565 from

1	the General Fund for FY2013-14 and (2) \$790,409 from the General Fund
2	for FY2014-15 to the Nebraska Supreme Court, for Program 7, to aid in
3	carrying out the provisions of Legislative Bill 306, One Hundred
4	<u>Third Legislature, First Session, 2013.</u>
5	Total expenditures for permanent and temporary salaries
6	and per diems from funds appropriated in this section shall not
7	exceed \$380,054 for FY2013-14 or \$779,112 for FY2014-15.
8	Sec. 5. There is hereby appropriated (1) \$47,826 from the
9	Compensation Court Cash Fund for FY2013-14 and (2) \$98,044 from the
10	Compensation Court Cash Fund for FY2014-15 to the Nebraska Workers'
11	Compensation Court, for Program 526, to aid in carrying out the
12	provisions of Legislative Bill 306, One Hundred Third Legislature,
13	<u>First Session, 2013.</u>
14	Total expenditures for permanent and temporary salaries
15	and per diems from funds appropriated in this section shall not
16	exceed \$47,143 for FY2013-14 or \$96,643 for FY2014-15.
17	Sec. 6. This act becomes operative on July 1, 2013.
18	Sec. 7. Since an emergency exists, this act takes effect
19	when passed and approved according to law.
