2	and 18-1741.02, Reissue Revised Statutes of Nebraska,
3	sections 60-331.01, 60-3,113, 60-3,113.01, 60-3,113.03,
4	60-3,113.06, 60-3,113.07, and 60-3,113.08, Revised
5	Statutes Cumulative Supplement, 2012, and sections
6	60-3,113.02, 60-3,113.04, and 60-3,113.05, Revised
7	Statutes Supplement, 2013; to eliminate obsolete
8	provisions related to handicapped or disabled parking
9	permits; to redefine a term; to harmonize provisions; to
10	repeal the original sections; and to outright repeal
11	sections 18-1738, 18-1738.01, 18-1738.02, 18-1739,
12	18-1740, 18-1741, and 18-1742, Reissue Revised Statutes
13	of Nebraska.

14 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 18-1736, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 18-1736 (1) A city or village may designate parking
- 4 spaces, including access aisles, for the exclusive use of (a)
- 5 handicapped or disabled persons whose motor vehicles display the
- 6 distinguishing license plates issued to handicapped or disabled
- 7 persons pursuant to section 60-3,113, (b) handicapped or disabled
- 8 persons whose motor vehicles display a distinguishing license plate
- 9 issued to a handicapped or disabled person by another state, (c) such
- 10 other handicapped or disabled persons or temporarily handicapped or
- 11 disabled persons whose motor vehicles display a handicapped or
- 12 disabled parking permit, and (d) such other motor vehicles which
- 13 display a handicapped or disabled parking permit.
- 14 (2) If a city or village so designates a parking space or
- 15 access aisle, it shall be indicated by posting aboveground and
- 16 immediately adjacent to and visible from each space or access aisle a
- 17 sign as described in section 18-1737. In addition to such sign, the
- 18 space or access aisle may also be indicated by blue paint on the curb
- 19 or edge of the paved portion of the street adjacent to the space or
- 20 access aisle.
- 21 (3) For purposes of sections 18-1736 to 18-1742:
- 22 <u>18-1741.07</u>:
- 23 (a) Access aisle has the same meaning as in section
- 24 60-302.01;
- 25 (b) Handicapped or disabled parking permit has the same

- 1 meaning as in section 60-331.01;
- 2 (c) Handicapped or disabled person has the same meaning
- 3 as in section 60-331.02; and
- 4 (d) Temporarily handicapped or disabled person has the
- 5 same meaning as in section 60-352.01.
- 6 Sec. 2. Section 18-1741.02, Reissue Revised Statutes of
- 7 Nebraska, is amended to read:
- 8 18-1741.02 (1) Any person found guilty of a handicapped
- 9 parking infraction shall be fined (a) not more than one hundred fifty
- 10 dollars for the first offense, (b) not more than three hundred
- 11 dollars for a second offense within a one-year period, and (c) not
- 12 more than five hundred dollars for a third or subsequent offense
- 13 within a one-year period.
- 14 (2) In addition to any fine imposed under subsection (1)
- 15 of this section, any person found guilty of a handicapped parking
- 16 infraction under section 18-1741 or section 60-3,113.06 shall be
- 17 subject to suspension of such person's handicapped or disabled
- 18 parking permit for six months and such other punishment as may be
- 19 provided by local ordinance. In addition, the court shall impose a
- 20 fine of not more than two hundred fifty dollars which may be waived
- 21 by the court if, at the time of sentencing, all handicapped or
- 22 disabled parking permits issued to or in the possession of the

2 (2) A handicapped or disabled person or temporarily 3 handicapped or disabled person or his or her parent, legal guardian, 4 foster parent, or certifying health care provider may apply for a 5 handicapped or disabled parking permit to the department or through a 6 health care provider using a secure online process developed by the 7 department which will entitle the holder of a permit or a person 8 driving a motor vehicle for the purpose of transporting such holder 9 to park in those spaces or access aisles provided for by sections 18-1736 and 18-1737 when the holder of the permit will enter or exit 10 the motor vehicle while it is parked in such spaces or access aisles. 11 For purposes of this section, (a) the handicapped or disabled person 12 13 or temporarily handicapped or disabled person is considered the holder of the permit and (b) certifying health care provider means 14 15 the physician, physician assistant, or advanced practice registered 16 nurse who makes the certification required in subsection $\frac{(3)}{(2)}$ of this section or his or her designee. 17 (3) The application process for a handicapped or 18 19 disabled parking permit or for the renewal of a permit under this 20 section shall include presentation of proof of identity by the 21 handicapped or disabled person or temporarily handicapped or disabled 22 person and certification by a physician, a physician assistant, or an advanced practice registered nurse practicing under and in accordance 23 24 with his or her certification act that the person who will be the 25 holder meets the statutory criteria for qualification. An application

1 for the renewal of a permit under this section may be submitted

- 2 within one hundred eighty days prior to the expiration of the permit.
- 3 No applicant shall be required to provide his or her social security
- 4 number. In the case of a temporarily handicapped or disabled person,
- 5 the certifying physician, physician assistant, or advanced practice

- 4 space or access aisle. The notice shall also indicate that those
- 5 convicted of handicapped parking infractions shall be subject to
- 6 suspension of the permit for six months. The identification card
- 7 shall show the expiration date of the permit and such identifying
- 8 information with regard to the handicapped or disabled person or
- 9 temporarily handicapped or disabled person to whom the permit is
- 10 issued as is necessary to the enforcement of sections 18-1736 to
- 11 18-1741.07 as determined by the department.

(3)—(2) A person applying for a handicapped or disabled 6 7 parking permit or for the renewal of a permit pursuant to this 8 section shall apply for a permit for each motor vehicle used for the transportation of handicapped or disabled persons or temporarily 9 handicapped or disabled persons and shall include such information as 10 11 is required by the department, including a demonstration to the 12 department that each such motor vehicle is used primarily for the 13 transportation of handicapped or disabled persons or temporarily handicapped or disabled persons. An application for the renewal of a 14 permit under this section may be submitted within one hundred eighty 15 16 days prior to the expiration of the permit.

(4)—(3) The department, upon receipt of a completed application, shall verify that the applicant qualifies for a handicapped or disabled parking permit under this section and, if so, shall deliver the permit to the applicant. In issuing renewed permits, the department shall deliver each individual renewed permit to the applicant. The renewed permit shall not be issued sooner than ten days prior to the date of expiration, and the existing permit shall be invalid upon receipt of the renewed permit. No more than one such permit shall be issued for each motor vehicle under this

- 1 section.
- 2 (5) (4) In issuing any handicapped or disabled parking
- 3 permit under this section, the department shall include a notice and
- 4 an identification card to the registered owner of the motor vehicle
- 5 or the applicant. The notice shall contain information listing the
- 6 legal uses of the permit and that the permit is not transferable, is
- 7 to be used for the motor vehicle for which it is issued, is not to be
- 8 altered or reproduced, and is to be used only when a handicapped or
- 9 disabled person or a temporarily handicapped or disabled person will
- 10 enter or exit the motor vehicle while it is parked in a designated
- 11 parking space or access aisle. The notice shall also indicate that
- 12 those convicted of handicapped parking infractions shall be subject
- 13 to suspension of the permit for six months. The identification card
- 14 shall identify the motor vehicle for which the permit is issued as is
- 15 necessary to the enforcement of sections 18-1736 to 18-1741.07 as
- 16 determined by the department.

1 UNIFORM SYSTEM FOR PARKING FOR PERSONS WITH DISABILITIES, as such

- 3 (3)—(2) No handicapped or disabled parking permit shall
- 4 be issued to any person or for any motor vehicle if any permit has
- 5 been issued to such person or for such motor vehicle and such permit
- 6 has been suspended pursuant to section 18-1741.02. At the expiration
- 7 of such suspension, a permit may be renewed in the manner provided
- 8 for renewal in sections 60-3,113.02, 60-3,113.03, and 60-3,113.05.
- 9 (4)—(3) A duplicate handicapped or disabled parking
- 10 permit may be provided up to two times during any single permit
- 11 period if a permit is destroyed, lost, or stolen. Such duplicate

A handicapped or disabled parking permit shall be 4 displayed on the dashboard only when there is no rearview mirror. No 5 person shall alter or reproduce in any manner a handicapped or 6 disabled parking permit. No person shall knowingly hold more than the 7 allowed number of handicapped or disabled parking permits. No person shall display 13 a handicapped or disabled parking permit issued under section 60-3,113.03 and park in a space or access aisle designated for the 14 15 exclusive use of a handicapped or disabled person unless the person displaying the permit is driving the motor vehicle for which the 16 permit was issued and a handicapped or disabled person will enter or 17 exit the motor vehicle while it is parked in a designated space or 18 access aisle. Any violation of this subsection section shall 19 20 constitute a handicapped parking infraction as defined in section 18-1741.01 and shall be subject to the penalties and procedures set 21 forth in sections 18-1741.01 to 18-1741.07. 22
