 of the claims; to authorize agencies to write off certain
 claims as prescribed; and to declare an emergency.

23	authorized and directed to draw his or her warrants upon the funds in
24	the state treasury enumerated in this act, in favor of the several

- 2 respective names upon the presentation of proper vouchers therefor.
- 3 The several amounts appropriated in this act shall be in full payment
- 4 of any and all claims, rights, causes of action, damages, and demands
- 5 of every character and kind owing by or against the State of
- 6 Nebraska, its officers, agents, and employees, and their successors
- 7 and assigns with respect to each of the beneficiaries respectively in
- 8 whose favor the appropriations are made. The director shall not
- 9 deliver any warrant for any items appropriated in this act until a
- 10 receipt and release in full, releasing the State of Nebraska, its
- officers, employees, and agents, and their successors and assigns,
