- 3 32-567 Vacancies in office shall be filled as follows:
- 4 (1) In state and judicial district offices and in the
- 5 membership of any board or commission created by the state when no
- 6 other method is provided, by the Governor;
- 7 (2) In county offices, by the county board;
- 8 (3) In the membership of the county board, by the county
- 9 clerk, county attorney, and county treasurer;
- 10 (4) In the membership of the city council, according to
- 11 section 32-568 or 32-569, as applicable;
- 12  $\frac{(4)-(5)}{(5)}$  In township offices, by the township board or, if
- 13 there are two or more vacancies on the township board, by the county
- 14 board;
- 15 (5) (6) In offices in public power and irrigation
- 16 districts, according to section 70-615;
- 17  $\frac{(6)-(7)}{}$  In offices in natural resources districts,
- 18 according to section 2-3215;
- 19  $\frac{(7)}{(8)}$  In offices in community college areas, according
- 20 to section 85-1514;

- (13) In membership on the council of a municipal

- 10 Unless otherwise provided by law, all vacancies shall be
- 11 filled within forty-five days after the vacancy occurs. unless good
- 12 cause is shown that the requirement imposes an undue burden.
- Sec. 2. Original section 32-567, Reissue Revised Statutes
- of Nebraska, is repealed.
