A BILL

1 FOR AN ACT relating to appropriations; to amend Laws 2013, LB198,
2 section 11; to appropriate funds to aid in carrying out
3 the provisions of Legislative Bill 999, One Hundred Third
4 Legislature, Second Session, 2014; and to repeal the
5 original section.
6 Be it enacted by the people of the State of Nebraska,

14 The Department of Health and Human Services is hereby
 15 authorized to renovate Building No. 3 at the Hastings Regional Center
 16 to house the chemical dependency program serving adolescent males in
 17 state custody.

18 There is included in the future appropriations to this
 19 program an estimated ~~\$3,097,000~~ \$2,897,000 to demolish buildings at
 20 the Hastings Regional Center determined by the Vacant Building and
 21 Excess Land Committee to be vacant as defined in section 72-811,
 22 contingent on the actions pursuant to the program statement as
 23 provided for in Legislative Bill 999, One Hundred Third Legislature,
 24 Second Session, 2014, for Program 930 - Hastings Correctional

1 Behavioral Health Treatment Center.

2 Sec. 2. There is hereby appropriated (1) \$200,000 from
3 the General Fund for FY2014-15 and (2) -\$0- from the General Fund for
4 FY2015-16 to the Department of Health and Human Services, for Program
5 930 - Hastings Correctional Behavioral Health Treatment Center, to
6 aid in carrying out the provisions of Legislative Bill 999, One
7 Hundred Third Legislature, Second Session, 2014.

8 No expenditures for permanent and temporary salaries and
9 per diems for state employees shall be made from funds appropriated
10 in this section.

11 The Division of Behavioral Health of the Department of
12 Health and Human Services is hereby authorized to prepare a program
13 statement as specified in Legislative Bill 999, One Hundred Third
14 Legislature, Second Session, 2014.

15 Sec. 3. Original Laws 2013, LB198, section 11, is
16 repealed.
