LEGISLATIVE BILL 907A

Approved by the Governor April 16, 2014

Introduced by Ashford, 20.

FOR AN ACT relating to appropriations; to appropriate funds to aid in carrying out the provisions of Legislative Bill 907, One Hundred Third Legislature, Second Session, 2014; to provide for a transfer of funds; and to declare an emergency.

Be it enacted by the people of the State of Nebraska,

Section 1. There is hereby appropriated (1) \$8,800,000 from the General Fund for FY2014-15 and (2) \$8,800,000 from the General Fund for FY2015-16 to the Supreme Court, for Program 435, to aid in carrying out the provisions of Legislative Bill 907, One Hundred Third Legislature, Second Session, 2014.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$1,561,589 for FY2014-15 or \$1,600,629 for FY2015-16.

Sec. 2. There is hereby appropriated (1) \$200,000 from the General Fund for FY2014-15 and (2) \$200,000 from the General Fund for FY2015-16 to the Board of Regents of the University of Nebraska for the University of Nebraska at Omaha, for Program 781, to aid in carrying out the provisions of Legislative Bill 907, One Hundred Third Legislature, Second Session, 2014.

Sec. 3. There is hereby appropriated (1) \$5,000,000 from the General Fund for FY2014-15 and (2) \$5,000,000 from the General Fund for FY2015-16 to the Department of Correctional Services, for Program 214 - Vocational and Life Skills Program, to aid in carrying out the provisions of Legislative Bill 907, One Hundred Third Legislature, Second Session, 2014.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$1,109,100 for FY2014-15 or \$1,129,100 for FY2015-16.

There is included in the appropriation to this program for FY2014-15 \$3,500,000 General Funds for state aid, which shall only be used for such purpose. Sec. 4. There is hereby appropriated (1) \$269,362 from the General Fund for FY2014-15 and (2) \$252,337 from the General Fund for FY2015-16 to the Department of Correctional Services, for Program 200, to aid in carrying out the provisions of Legislative Bill 907, One Hundred Third Legislature, Second Session, 2014.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$194,105 for FY2014-15 or \$194,105 for FY2015-16.

Sec. 5. There is hereby appropriated (1) \$152,500 from the Legal Education for Public Service and Rural Practice Loan Repayment Assistance Fund for FY2014-15 and (2) \$151,500 from the Legal Education for Public Service and Rural Practice Loan Repayment Assistance Fund for FY2015-16 to the Commission on Public Advocacy, for Program 430 - Rural Practice Loan Repayment Assistance, to aid in carrying out the provisions of Legislative Bill 907, One Hundred Third Legislature, Second Session, 2014.

No expenditures for permanent and temporary salaries and per diems for state employees shall be made from funds appropriated in this section.

There is included in the appropriation to this program for FY2014-15 \$150,000 Legal Education for Public Service and Rural Practice Loan Repayment Assistance Fund for state aid, which shall only be used for such purpose. There is included in the appropriation to this program for FY2015-16 \$150,000 Legal Education for Public Service and Rural Practice Loan Repayment Assistance Fund for state aid, which shall only be used for such purpose.

Sec. 6. The State Treasurer shall transfer five hundred thousand dollars from the General Fund to the Legal Education for Public Service and Rural Practice Loan Repayment Assistance Fund on or before July 11, 2014.

Sec. 7. Since an emergency exists, this act takes effect when passed and approved according to law.
