Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill sets forth requirements for children in the foster care system to engage in age and developmentally appropriate activities and for the reasonable and prudent parent standard to be used to make the decision on allowing a child to participate. The bill also requires children who are aging out of foster care or the Bridge to Independence Program to be given specific information such as a copy of their medical records, a driver's license or identification card, education records, a credit report, a list of community resources, contact information for family members, and community resources the young adult may need.

An additional staff assistant position is needed in the Department of Health and Humans Services. The cost would be \$48,850 GF in FY 17 and \$46,850 in FY 18. The Supreme Court would need to update education for guardians ad litem and judges and update forms. One-time expenditures would be \$15,000 in FY 17 from cash funds.
