- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated \$15,000 from the Supreme
- 2 Court Education Fund for FY2016-17 to the Supreme Court, for Program 52,
- 3 to aid in carrying out the provisions of Legislative Bill 746, One
- 4 Hundred Fourth Legislature, Second Session, 2016.
- 5 <u>No expenditures for permanent and temporary salaries and per diems</u>
- 6 for state employees shall be made from funds appropriated in this
- 7 section.
- 8 Sec. 2. There is hereby appropriated (1) \$130,000 from the Health
- 9 Care Cash Fund for FY2016-17 and (2) \$190,000 from the General Fund for
- 10 <u>FY2017-18 to the Foster Care Review Office, for Program 353, to aid in</u>
- 11 <u>carrying out the provisions of Legislative Bill 746, One Hundred Fourth</u>
- 12 <u>Legislature, Second Session, 2016.</u>
- 13 <u>Total expenditures for permanent and temporary salaries and per</u>
- 14 diems from funds appropriated in this section shall not exceed \$98,903
- 15 for FY2016-17 or \$98,903 for FY2017-18.
- 16 The unexpended General Fund appropriation balance existing on June
- 17 30, 2016, is hereby reappropriated.
