- 1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
- 2 in carrying out the provisions of Legislative Bill 1032, One Hundred
- 3 Fourth Legislature, Second Session, 2016; and to reduce
- 4 appropriations.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated \$36,928 from the Department
- 2 of Insurance Cash Fund for FY2017-18 to the Department of Insurance, for
- 3 Program 69, to aid in carrying out the provisions of Legislative Bill
- 4 1032, One Hundred Fourth Legislature, Second Session, 2016.
- 5 <u>Total expenditures for permanent and temporary salaries and per</u>
- 6 diems from funds appropriated in this section shall not exceed \$23,481
- 7 for FY2017-18.
- 8 Sec. 2. There is hereby appropriated (1) \$1,338,145 from the
- 9 General Fund and \$3,003,236 from federal funds for FY2016-17 and (2)
- 10 \$3,238,125 from the General Fund and \$5,431,039 from federal funds for
- 11 FY2017-18 to the Department of Health and Human Services, for Program 33,
- 12 to aid in carrying out the provisions of Legislative Bill 1032, One
- 13 <u>Hundred Fourth Legislature, Second Session, 2016.</u>
- 14 <u>Total expenditures for permanent and temporary salaries and per</u>
- 15 diems from funds appropriated in this section shall not exceed \$573,608
- 16 for FY2016-17 or \$3,517,175 for FY2017-18.
- 17 Sec. 3. There is hereby appropriated \$9,708,413 from the General
- 18 Fund, \$230,441 from the Transitional Health Insurance Program Fund, and
- 19 \$152,098,474 from federal funds for FY2017-18 to the Department of Health
- 20 and Human Services, for Program 349, to aid in carrying out the
- 21 provisions of Legislative Bill 1032, One Hundred Fourth Legislature,
- 22 Second Session, 2016.
- 23 <u>No expenditures for permanent and temporary salaries and per diems</u>
- 24 for state employees shall be made from funds appropriated in this
- 25 section.
- Sec. 4. <u>The General Fund appropriation for FY2017-18 to the</u>
- 27 Department of Health and Human Services, for Program 38, is hereby
- 28 reduced by \$2,400,000.
- 29 Sec. 5. <u>The General Fund appropriation for FY2017-18 to the</u>
- 30 Department of Health and Human Services, for Program 344, is hereby
- 31 reduced by \$9,292.

- 1 Sec. 6. The General Fund appropriation for FY2017-18 to the
- 2 Department of Health and Human Services, for Program 347, is hereby
- 3 reduced by \$1,119,800.
- 4 The reduction to this program is the net amount of an increase for
- 5 <u>the Health Insurance Employment Program and a reduction to the State</u>
- 6 <u>Disability Program.</u>
- 7 Sec. 7. The General Fund appropriation for FY2017-18 to the
- 8 <u>Department of Health and Human Services</u>, for Program 348, is hereby
- 9 <u>reduced by \$11,958,196.</u>
- 10 Sec. 8. <u>The General Fund appropriation for FY2017-18 to the</u>
- 11 Department of Health and Human Services, for Program 514, is hereby
- 12 reduced by \$450,000.
- 13 Sec. 9. The General Fund appropriation for FY2017-18 to the
- 14 Department of Correctional Services, for Program 200, is hereby reduced
- 15 by \$63,500.
