- A BILL FOR AN ACT relating to the Nebraska Safe Drinking Water Act; to amend section 71-5301.01, Reissue Revised Statutes of Nebraska, and section 71-5301, Revised Statutes Cumulative Supplement, 2014; to change provisions relating to lead content; to redefine a term; to provide for rules and regulations; to harmonize provisions; and to
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 71-5301, Revised Statutes Cumulative Supplement,

- 2 2014, is amended to read:
- 3 71-5301 For purposes of the Nebraska Safe Drinking Water Act, unless
- 4 the context otherwise requires:
- 5 (1) Council means the Advisory Council on Public Water Supply;
- 6 (2) Department means the Division of Public Health of the Department 7 of Health and Human Services;
- 8 (3) Director means the Director of Public Health of the Division of
- 9 Public Health or his or her authorized representative;
- 10 (4) Designated agent means any political subdivision or corporate
- 11 entity having the demonstrated capability and authority to carry out in
- 12 whole or in part the Nebraska Safe Drinking Water Act and with which the
- 13 director has consummated a legal and binding contract covering
- 14 specifically delegated responsibilities;
- 15 (5) Major construction, extension, or alteration means those
- 16 structural changes that affect the source of supply, treatment processes,
- 17 or transmission of water to service areas but does not include the
- 18 extension of service mains within established service areas;
- 19 (6) Operator means the individual or individuals responsible for the
- 20 continued performance of the water supply system or any part of such
- 21 system during assigned duty hours;
- 22 (7) Owner means any person owning or operating a public water
- 23 system;
- 24 (8) Person means any individual, corporation, firm, partnership,
- 25 limited liability company, association, company, trust, estate, public or
- 26 private institution, group, agency, political subdivision, or other
- 27 entity or any legal successor, representative, agent, or agency of any of
- 28 such entities;
- 29 (9) Water supply system means all sources of water and their
- 30 surroundings under the control of one owner and includes all structures,
- 31 conduits, and appurtenances by means of which such water is collected,

1 treated, stored, or delivered except service pipes between street mains

2 and buildings and the plumbing within or in connection with the buildings

- 3 served;
- 4 (10)(a) Public water system means a system for providing the public
- 5 with water for human consumption through pipes or other constructed
- 6 conveyances, if such system has at least fifteen service connections or
- 7 regularly serves an average of at least twenty-five individuals daily at
- 8 least sixty days per year. Public water system includes (i) any
- 9 collection, treatment, storage, and distribution facilities under control
- 10 of the operator of such system and used primarily in connection with such
- 11 system and (ii) any collection or pretreatment storage facilities not
- 12 under such control which are used primarily in connection with such
- 13 system. Public water system does not include a special irrigation
- 14 district. A public water system is either a community water system or a
- 15 noncommunity water system.
- 16 (b) Service connection does not include a connection to a system
- 17 that delivers water by a constructed conveyance other than a pipe if (i)
- 18 the water is used exclusively for purposes other than residential uses,
- 19 consisting of drinking, bathing, cooking, and other similar uses, (ii)
- 20 the department determines that alternative water to achieve the
- 21 equivalent level of public health protection provided by the Nebraska
- 22 Safe Drinking Water Act and rules and regulations under the act is
- 23 provided for residential or similar uses for drinking and cooking, or
- 24 (iii) the department determines that the water provided for residential
- 25 or similar uses for drinking, cooking, and bathing is centrally treated
- 26 or treated at the point of entry by the provider, a pass-through entity,
- 27 or the user to achieve the equivalent level of protection provided by the
- 28 Nebraska Safe Drinking Water Act and the rules and regulations under the
- 29 act.
- 30 (c) Special irrigation district means an irrigation district in
- 31 existence prior to May 18, 1994, that provides primarily agricultural

- 1 service through a piped water system with only incidental residential or
- 2 similar use if the system or the residential or similar users of the
- 3 system comply with exclusion provisions of subdivision (b)(ii) or (iii)
- 4 of this subdivision;
- 5 (11) Drinking water standards means rules and regulations adopted
- 6 and promulgated pursuant to section 71-5302 which (a) establish maximum
- 7 levels for harmful materials which, in the judgment of the director, may
- 8 have an adverse effect on the health of persons and (b) apply only to
- 9 public water systems;
- 10 (12) Lead free means (a) not (a) when used with respect to solders
- 11 and flux means solders and flux containing not more than two-tenths
- 12 percent lead when used with respect to solder and flux and (b) not
- 13 <u>containing more than a weighted average of twenty-five hundredths percent</u>
- 14 <u>lead</u> , (b) when used with respect to the wetted surfaces of pipes, pipe
- 15 <u>fittings, plumbing fittings, and fixtures</u> pipes and pipe fittings means
- 16 pipes and pipe fittings containing not more than eight percent lead, and
- 17 (c) when used with respect to plumbing fittings and fixtures intended by
- 18 the manufacturer to dispense water for human ingestion means fittings and
- 19 fixtures that are in compliance with standards established in accordance
- 20 with 42 U.S.C. 300g-6(e) as such section existed on July 16, 2004;
- 21 (13) Community water system means a public water system that (a)
- 22 serves at least fifteen service connections used by year-round residents
- 23 of the area served by the system or (b) regularly serves at least twenty-
- 24 five year-round residents;
- 25 (14) Noncommunity water system means a public water system that is
- 26 not a community water system; and
- 27 (15) Nontransient noncommunity water system means a public water
- 28 system that is not a community water system and that regularly serves at
- 29 least twenty-five of the same individuals over six months per year.

- 1 71-5301.01 (1) After July 1, 1988, any pipe, pipe fitting, solder,
- 2 or flux which is used in the installation or repair of any public water
- 3 system shall be lead free.
- 4 (2) By July 1, 1988, the owner of any public water system shall, by
- 5 the adoption of plumbing codes or ordinances, contract, or other
- 6 enforceable means, require that any solder or flux used in the
- 7 installation or repair of any residential or nonresidential facility
- 8 which is connected to the public water system be lead free.
- 9 (3) The owner of any public water system shall inspect the
- 10 installation or repair of facilities described in subsection (2) of this
- 11 section to determine compliance with such subsection.
- 12 (4) The owner of a public water system shall cause any joint or pipe
- 13 in facilities described in subsection (2) of this section to be replaced
- 14 if the owner or the director finds that such joint or pipe is not lead
- 15 free.
- 16 (5) This section shall not apply to the repair of leaded joints in
- 17 cast iron pipes in any public water system that are in existence and use
- 18 on July 1, 1988.
- 19 The director may adopt and promulgate rules and regulations
- 20 regarding the use of lead-free materials in public water systems in
- 21 compliance with standards established in accordance with 42 U.S.C. 300g,
- 22 as such sections existed on January 1, 2016.
