The following constitutes the reasons for this bill and the purposes which are sought to be accomplished thereby:

LB 156 raises the aggregate amount of refundable tax credits available for qualifed investors or qualified funds from three million dollars to five million dollars per calendar year. The qualifed investors or qualified funds must invest in qualified small businesses in a qualified high-technology field. In addition, the small business must have 25 or fewer employees and have at least half of its payroll in Nebraska.
