## LEGISLATIVE BILL 746A

Approved by the Governor April 18, 2016

Introduced by Campbell, 25.

A BILL FOR AN ACT relating to appropriations; to amend Laws 2015, LB657, section 10; to appropriate funds to aid in carrying out the provisions of Legislative Bill 746, One Hundred Fourth Legislature, Second Session, 2016; to change an appropriation; to repeal the original section; and to declare an emergency.

Be it enacted by the people of the State of Nebraska,

There is hereby appropriated \$15,000 from the Supreme Court Section 1. Education Fund for FY2016-17 to the Supreme Court, for Program 52, to aid in carrying out the provisions of Legislative Bill 746, One Hundred Fourth Legislature, Second Session, 2016.

<u>No expenditures for permanent and temporary salaries and per diems for</u> <u>state employees shall be made from funds appropriated in this section.</u>

There is hereby appropriated (1) \$130,000 from the Health Care Sec. 2. Cash Fund for FY2016-17 and (2) \$190,000 from the General Fund for FY2017-18 to the Foster Care Review Office, for Program 353, to aid in carrying out the provisions of Legislative Bill 746, One Hundred Fourth Legislature, Second Second

<u>Session, 2016.</u> Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$98,903 for FY2016-17 or <u>\$98,903 for FY2017-18.</u> <u>The unexpended General Fund appropriation balance existing on June 30,</u>

There is included in the appropriation to this program for FY2015-16  $\frac{55,000}{75,000}$  Cash Funds and for FY2016-17  $\frac{515,000}{75,000}$  Cash Funds from the Nebraska Health Care Cash Fund for the purpose of ongoing health-related research and public policy development by the Health and Human Services Committee of the Legislature. Such funds may be used for, but shall not be limited to, hiring temporary legal research assistance, consulting and research contracts, reimbursement for necessary and appropriate expenses incurred in connection with such research and policy development, and actual and necessary travel reimbursement for task forces and committees established to conduct health policy work.

The unexpended General Fund appropriation balance existing on June 30, 2015, is hereby reappropriated.

Sec. 4. Original Laws 2015, LB657, section 10, is repealed. Sec. 5. Since an emergency exists, this act takes effect when passed and approved according to law.
