Summary of purpose and/or changes:

LB 1034 requires the standards for care and protection of children, for school-age child care programs, located within an accredited or approved school are deemed to meet the same standards of an accredited or approved school under the regulations of the State Department of Education.

SECTION BY SECTION:

Section 1: Amends Section 71-1913 to require the standards for care and protection of children, for school-age child care programs, located within an accredited or approved school are deemed to meet the same standards of an accredited or approved school under the regulations of the State Department of Education.

Section 2: Repeals Section 71-1913.

Explanation of amendments:

AM 2322 is a white copy amendment and includes the provisions of LB 344, LB 686, LB 894, LB 924, and LB 1057. For more details, please see each bill's individual committee statement.

AM 2322 strikes the original sections. Creates new section within the Child Care Licensing Act. Provides exception for school-age child care programs regarding fire and health inspections. Provides requirements for licensed school-age child care programs, operating in an accredited or approved school, shall be deemed to meet the standards of the Department of Education for care and protection of children. Mandates the Department of Health and Human Services

to provide inspections for the programs. Provides the Department of Health and Human Services the ability to adopt and promulgate rules and regulations in consultation with the State Department of Education.
