Summary of purpose and/or changes:

LB 731 provides requirements for remote dispensing to the pharmacist in charge of a supervising pharmacy.

SECTION BY SECTION:

Section 1: Amends Section 38-2801 to add sections to the Pharmacy Practice Act.

Section 2: Amends Section 38-2802 to add sections.

Section 3: Amends Section 38-2833 to add remote dispensing license to definition of "pharmacist in charge."

Section 4: Defines "remote dispensing" as found in Section 15 of act.

Section 5: Defines "remote dispensing pharmacy" as found in Section 16 of act.

Section 6: Defines "supervising pharmacy" as found in Section 17 of act.

Section 7: Amends Section 38-2847 to update the definition of "verification" to include verification by a pharmacist of a pharmacy technician activities may be done via real-time audiovisual communications systems for the purposes of

remote dispensing.

Section 8: Amends Section 38-2870 to authorize a practitioner or practitioner's agent to transmit a medical order for an authorized refill to a pharmacy technician.

Section 9: Amends Section 38-2891 to clarify the mandate that pharmacy technicians are not allowed to perform tasks that require the professional judgment of a pharmacist.

Section 10: Amends Section 38-2892 to add remote dispensing pharmacy to the list of responsibilities for a pharmacist in charge in supervision and oversight of a pharmacy technician.

Section 11: Amends Section 38-28,106 to authorize a practitioner or practitioner's agent to transmit a medical order for an authorized refill to a pharmacy technician.

Section 12: Amends Section 71-401 to add new sections to the Health Care Facility Act.

Section 13: Amends Section 71-403 to add new sections.

Section 14: Amends Section 71-425 to update the definition of "pharmacy" to include remote dispensing pharmacy.

Section 15: Defines "remote dispensing."

Section 16: Defines "remote dispensing pharmacy."

Section 17: Defines "supervising pharmacy."

Section 18: Authorizes remote dispensing and specifies licensure requirements, supervision requirements for real-time audio visual communication, pharmacist in charge duties, and patient counseling by a pharmacist.

Section 19: Amends Section 71-2448 to add remote dispensing pharmacy to locations where prescription medication distribution machines may be used.

Section 20: Amends Section 71-2483 to authorize a practitioner or practitioner's agent to transmit a medical order for an authorized refill to a pharmacy technician.

Section 21: Repeal Sections 38-2833, 38-2847, 38-2891, 38-28,106, 71-425, 71-2448, 71-2483, 38-2501, 38-2802, 38-2870, 38-2892, and 71-407.

Explanation of amendments:

AM 2352 is a white copy amendment. AM 2352 includes portions of LB 681, LB 788, LB 790 and LB 1107. AM 2352 strikes the original bill of LB 731, however retains the original Sections 1-21. AM 2352 adds an exception that a pharmacist in charge is not required to work within the physical confines of a remote dispensing pharmacy unless otherwise required by law. Mandates a pharmacy shall not be licensed as both a remote dispensing pharmacy and a pharmacy.
