Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would provide requirements for inmate access to telephone or videoconferencing systems in county and city jails. The officer in charge of any municipal prison or jail who fails to comply with the provisions of this bill shall be guilty of a Class V misdemeanor.

The Crime Commission estimates no fiscal impact from this bill.

The Cities of Imperial, Fremont, Omaha, and Lincoln all estimate no fiscal impact from this bill.

The Lancaster County Department of Corrections states that enacting this bill would impact a revenue stream currently used to fund various inmate programs (see their response for a detailed listing of programs). They estimate they would have to eliminate those programs or seek property tax funds to retain those inmate programs.

Any fines assessed pursuant to convictions will accrue to the county where the violation occurs to be used for the support of public schools. This amount is not known at this time.
