Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 807 requires the Secretary of State to submit to the United States Architect of the Capitol a written request to approve the replacement of the statue of Julius Sterling Morton currently on display in the National Statuary Hall Collection in the United States Capitol with a statue of Willa Cather.

Section 3 creates the National Statuary Hall Selection Committee. Upon approval by the Joint Committee of the Library of Congress pursuant to the agreement described in section 2 of the bill, the National Statuary Hall Selection Committee shall:

- Select a sculptor to create a statue of Willa Cather;
- Identify a method to obtain necessary funding to pay for all of the following:
  - The sculptor for designing and carving or casting the statue
  - The design and fabrication of the pedestal
  - The transportation of the statue and pedestal to the United States Capitol
  - The removal and transportation of the replaced statue
  - The temporary placement of the new statue for the unveiling ceremony
  - The unveiling ceremony
  - o Any other expenses that the committee determines are necessary.

The Nebraska State Historical Society (NSHS) estimates the cost to accomplish the bill's provisions to be \$150,000 per year. Since the funds would need to be raised, they are shown as Cash Funds in both the expenditure and revenue columns. The NSHS notes that the cost of an unveiling ceremony are highly variable and not included in this estimate. Furthermore, it should be noted that these costs are based on previous similar activities but may not be reflective of the actual costs eventually incurred. There is no basis to disagree with the estimates provided, but they may be significantly higher than anticipated.

Explanation of Estimate:

This bill creates the National Statuary Hall Selection Committee consisting of members of the NE Hall of Fame Commission who must find a method to raise funds necessary to pay for a replacement of the Julius Sterling Morton statue in the National Statuary Hall of the United States Capitol with a statue of Willa Cather. This cost estimate is based on the 2017 costs for the design, fabrication, and transportation of the statue of Standing Bear in Lincoln, and on a 2014 proposal for an Ohio statue of Thomas Edison at the United States Capitol. The costs of an unveiling ceremony are highly variable and are not included in this estimate.

**Explanation of Estimate:** 

LB807 requires, upon approval of the Joint Committee on the Library of Congress for the replacement of the statue of Julius Sterling Morton with a statue of Willa Cather in the National Statuary Hall Collection of the United States Capitol, the Director of Administrative Services will enter into an agreement with the United State Architect of the Capitol to provide the replacement statue and to remove the statue being replaced. The agreement will include clauses to the effect that the State shall pay any costs related to the replacement, including costs in connection with the design, construction, transportation, and placement of the new statue, the removal and transportation of the statue being replaced, and any unveiling ceremony.

Section 3 of the bill creates the National Statuary Hall Selection Committee and tasks such committee to identify a method to obtain the necessary funding to pay for the various tasks described in the bill.

The bill, as written, tasks the Director of Administrative Services to enter into the agreement with the United States Architect, and such drafting of the agreement would fall within the normal operations of DAS and should only require an estimated five (5) to twenty (20) hours to prepare.

There is no fiscal impact to the Department of Administrative Services. There is a fiscal impact to the newly created Committee.
