1 A BILL FOR AN ACT relating to juveniles; to amend sections 43-285 and
2 43-1311.02, Reissue Revised Statutes of Nebraska, and sections
3 43-1303, 43-4318, and 43-4406, Revised Statutes Supplement, 2017; to
4 provide for waiver of notice of placement notifications; to provide
5 for a written sibling placement report and change provisions
6 relating to sibling visitation and placement; to provide for
7 additional information relating to foster care placements as
8 prescribed; to require reporting of allegations of sexual abuse as
9 prescribed; to eliminate obsolete provisions regarding the N-FOCUS
10 system; to harmonize provisions; and to repeal the original
11 sections.
12 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 43-285, Reissue Revised Statutes of Nebraska, is
2 amended to read:

3 43-285 (1) When the court awards a juvenile to the care of the
4 Department of Health and Human Services, an association, or an individual
5 in accordance with the Nebraska Juvenile Code, the juvenile shall, unless
6 otherwise ordered, become a ward and be subject to the legal custody and
7 care of the department, association, or individual to whose care he or
8 she is committed. Any such association and the department shall have
9 authority, by and with the assent of the court, to determine the care,
10 placement, medical services, psychiatric services, training, and
11 expenditures on behalf of each juvenile committed to it. Any such
12 association and the department shall be responsible for applying for any
13 health insurance available to the juvenile, including, but not limited
14 to, medical assistance under the Medical Assistance Act. Such custody and
15 care shall not include the guardianship of any estate of the juvenile.

16 (2)(a) Following an adjudication hearing at which a juvenile is
17 adjudged to be under subdivision (3)(a) or (c) of section 43-247, the
18 court may order the department to prepare and file with the court a
19 proposed plan for the care, placement, services, and permanency which are
20 to be provided to such juvenile and his or her family. The health and
21 safety of the juvenile shall be the paramount concern in the proposed
22 plan.

23 (b) The department shall provide opportunities for the child, in an
24 age or developmentally appropriate manner, to be consulted in the
25 development of his or her plan as provided in the Nebraska Strengthening
26 Families Act.

27 (c) The department shall include in the plan for a child who is
28 fourteen years of age or older and subject to the legal care and custody
29 of the department a written independent living transition proposal which
30 meets the requirements of section 43-1311.03 and, for eligible children,
31 the Young Adult Bridge to Independence Act. The juvenile court shall

1 provide a copy of the plan to all interested parties before the hearing.
2 The court may approve the plan, modify the plan, order that an
3 alternative plan be developed, or implement another plan that is in the
4 child's best interests. In its order the court shall include a finding
5 regarding the appropriateness of the programs and services described in
6 the proposal designed to help the child prepare for the transition from
7 foster care to a successful adulthood. The court shall also ask the
8 child, in an age or developmentally appropriate manner, if he or she
9 participated in the development of his or her plan and make a finding
10 regarding the child's participation in the development of his or her plan
11 as provided in the Nebraska Strengthening Families Act. Rules of evidence
12 shall not apply at the dispositional hearing when the court considers the
13 plan that has been presented.

14 (d) The last court hearing before jurisdiction pursuant to
15 subdivision (3)(a) of section 43-247 is terminated for a child who is
16 sixteen years of age or older shall be called the independence hearing.
17 In addition to other matters and requirements to be addressed at this
18 hearing, the independence hearing shall address the child's future goals
19 and plans and access to services and support for the transition from
20 foster care to adulthood consistent with section 43-1311.03 and the Young
21 Adult Bridge to Independence Act. The child shall not be required to
22 attend the independence hearing, but efforts shall be made to encourage
23 and enable the child's attendance if the child wishes to attend,
24 including scheduling the hearing at a time that permits the child's
25 attendance. An independence coordinator as provided in section 43-4506
26 shall attend the hearing if reasonably practicable, but the department is
27 not required to have legal counsel present. At the independence hearing,
28 the court shall advise the child about the bridge to independence
29 program, including, if applicable, the right of young adults in the
30 bridge to independence program to request a court-appointed, client-
31 directed attorney under subsection (1) of section 43-4510 and the

1 benefits and role of such attorney and to request additional permanency
2 review hearings in the bridge to independence program under subsection
3 (5) of section 43-4508 and how to request such a hearing. The court shall
4 also advise the child, if applicable, of the rights he or she is giving
5 up if he or she chooses not to participate in the bridge to independence
6 program and the option to enter such program at any time between nineteen
7 and twenty-one years of age if the child meets the eligibility
8 requirements of section 43-4504. The department shall present information
9 to the court regarding other community resources that may benefit the
10 child, specifically information regarding state programs established
11 pursuant to 42 U.S.C. 677. The court shall also make a finding as to
12 whether the child has received the documents as required by subsection
13 (9) of section 43-1311.03.

14 (3)(a) {3} Within thirty days after an order awarding a juvenile to
15 the care of the department, an association, or an individual and until
16 the juvenile reaches the age of majority, the department, association, or
17 individual shall file with the court a report stating the location of the
18 juvenile's placement and the needs of the juvenile in order to effectuate
19 the purposes of subdivision (1) of section 43-246. The department,
20 association, or individual shall file a report with the court once every
21 six months or at shorter intervals if ordered by the court or deemed
22 appropriate by the department, association, or individual. Every six
23 months, the report shall provide an updated statement regarding the
24 eligibility of the juvenile for health insurance, including, but not
25 limited to, medical assistance under the Medical Assistance Act. The
26 department shall also concurrently file a written sibling placement
27 report as described in subsection (3) of section 43-1311.02 at these
28 times.

29 (b) The department, association, or individual shall file a report
30 and notice of placement change with the court and shall send copies of
31 the notice to all interested parties, including all of the child's

1 siblings that are known to the department, at least seven days before the
2 placement of the juvenile is changed from what the court originally
3 considered to be a suitable family home or institution to some other
4 custodial situation in order to effectuate the purposes of subdivision
5 (1) of section 43-246. The department, association, or individual shall
6 afford a parent or an adult sibling the option of refusing to receive
7 such notifications. The court, on its own motion or upon the filing of an
8 objection to the change by an interested party, may order a hearing to
9 review such a change in placement and may order that the change be stayed
10 until the completion of the hearing. Nothing in this section shall
11 prevent the court on an ex parte basis from approving an immediate change
12 in placement upon good cause shown. The department may make an immediate
13 change in placement without court approval only if the juvenile is in a
14 harmful or dangerous situation or when the foster parents request that
15 the juvenile be removed from their home. Approval of the court shall be
16 sought within twenty-four hours after making the change in placement or
17 as soon thereafter as possible.

18 (c) The department shall provide the juvenile's guardian ad litem
19 with a copy of any report filed with the court by the department pursuant
20 to this subsection.

21 (4) The court shall also hold a permanency hearing if required under
22 section 43-1312.

23 (5) When the court awards a juvenile to the care of the department,
24 an association, or an individual, then the department, association, or
25 individual shall have standing as a party to file any pleading or motion,
26 to be heard by the court with regard to such filings, and to be granted
27 any review or relief requested in such filings consistent with the
28 Nebraska Juvenile Code.

29 (6) Whenever a juvenile is in a foster care placement as defined in
30 section 43-1301, the Foster Care Review Office or the designated local
31 foster care review board may participate in proceedings concerning the

1 juvenile as provided in section 43-1313 and notice shall be given as
2 provided in section 43-1314.

3 (7) Any written findings or recommendations of the Foster Care
4 Review Office or the designated local foster care review board with
5 regard to a juvenile in a foster care placement submitted to a court
6 having jurisdiction over such juvenile shall be admissible in any
7 proceeding concerning such juvenile if such findings or recommendations
8 have been provided to all other parties of record.

9 (8) The executive director and any agent or employee of the Foster
10 Care Review Office or any member of any local foster care review board
11 participating in an investigation or making any report pursuant to the
12 Foster Care Review Act or participating in a judicial proceeding pursuant
13 to this section shall be immune from any civil liability that would
14 otherwise be incurred except for false statements negligently made.

15 Sec. 2. Section 43-1303, Revised Statutes Supplement, 2017, is
16 amended to read:

17 43-1303 (1) The office shall maintain the statewide register of all
18 foster care placements occurring within the state, and there shall be a
19 weekly report made to the registry of all foster care placements by the
20 Department of Health and Human Services, any child-placing agency, or any
21 court in a form as developed by the office in consultation with
22 representatives of entities required to make such reports. For each child
23 entering and leaving foster care, such report shall consist of
24 identifying information, placement information, the plan or permanency
25 plan developed by the person or court in charge of the child pursuant to
26 section 43-1312, and information on whether any such child was a person
27 immune from criminal prosecution under subsection (5) of section 28-801
28 or was considered a trafficking victim as defined in section 28-830. The
29 department, the Office of Probation Administration, and every court and
30 child-placing agency shall report any foster care placement within three
31 working days. The report shall contain the following information:

1 (a) Child identification information, including name, date of birth,
2 gender, race, religion, and ethnicity;

3 (b) Identification information for parents and stepparents,
4 including name, address, and status of parental rights;

5 (c) Placement information, including (i) initial placement date,
6 (ii) current placement date, (iii) ~~and~~ the name and address of the foster
7 care placement, (iv) if a relative placement or kinship placement,
8 whether the foster care placement is licensed, and (v) whether the foster
9 care placement has received a waiver pursuant to section 71-1904 and the
10 basis for such waiver;

11 (d) Court status information, including which court has
12 jurisdiction, initial custody date, court hearing date, and results of
13 the court hearing;

14 (e) Agency or other entity having custody of the child; and

15 (f) Case worker, probation officer, or person providing direct case
16 management or supervision functions.

17 (2)(a) The Foster Care Review Office shall designate a local board
18 to conduct foster care file audit case reviews for each case of children
19 in foster care placement.

20 (b) The office may adopt and promulgate rules and regulations for
21 the following:

22 (i) Establishment of training programs for local board members which
23 shall include an initial training program and periodic inservice training
24 programs;

25 (ii) Development of procedures for local boards;

26 (iii) Establishment of a central record-keeping facility for all
27 local board files, including foster care file audit case reviews;

28 (iv) Accumulation of data and the making of annual reports on
29 children in foster care placements. Such reports shall include, but not
30 be limited to, (A) personal data on length of time in foster care, (B)
31 number of placements, (C) frequency and results of foster care file audit

1 case reviews and court review hearings, (D) number of children supervised
2 by the foster care programs in the state annually, (E) trend data
3 impacting foster care, services, and placements, (F) analysis of the
4 data, and (G) recommendations for improving the foster care system in
5 Nebraska;

6 (v) Accumulation of data and the making of quarterly reports
7 regarding the children in foster care placements;

8 (vi) To the extent not prohibited by section 43-1310, evaluation of
9 the judicial and administrative data collected on foster care and the
10 dissemination of such data to the judiciary, public and private agencies,
11 the department, and members of the public; and

12 (vii) Manner in which the office shall determine the appropriateness
13 of requesting a court review hearing as provided for in section 43-1313.

14 (3) A local board shall send a written report to the office for each
15 foster care file audit case review conducted by the local board. A court
16 shall send a written report to the office for each foster care review
17 hearing conducted by the court.

18 (4) The office shall report and make recommendations to the
19 Legislature, the department, the Office of Probation Administration, the
20 courts, local boards, and county welfare offices. Such reports and
21 recommendations shall include, but not be limited to, the annual judicial
22 and administrative data collected on foster care pursuant to subsections
23 (2) and (3) of this section and the annual evaluation of such data. The
24 report and recommendations submitted to the Legislature shall be
25 submitted electronically. In addition, the Foster Care Review Office
26 shall provide copies of such reports and recommendations to each court
27 having the authority to make foster care placements. The executive
28 director of the office shall also provide, at a time specified by the
29 Health and Human Services Committee of the Legislature, regular
30 electronic updates regarding child welfare data and information at least
31 quarterly, and a fourth-quarter report which shall be the annual report.

1 The executive director shall include issues, policy concerns, and
2 problems which have come to the office and the executive director from
3 analysis of the data. The executive director shall recommend alternatives
4 to the identified problems and related needs of the office and the foster
5 care system to the committee. The Health and Human Services Committee
6 shall coordinate and prioritize data and information requests submitted
7 to the office by members of the Legislature. The annual report of the
8 office shall be completed by December 1 each year and shall be submitted
9 electronically to the committee.

10 (5) The executive director of the office or his or her designees
11 from the office may visit and observe foster care facilities in order to
12 ascertain whether the individual physical, psychological, and
13 sociological needs of each foster child are being met.

14 (6) At the request of any state agency, the executive director of
15 the office or his or her designees from the office may conduct a case
16 file review process and data analysis regarding any state ward or ward of
17 the court whether placed in-home or out-of-home at the time of the case
18 file review.

19 Sec. 3. Section 43-1311.02, Reissue Revised Statutes of Nebraska, is
20 amended to read:

21 43-1311.02 (1)(a) Reasonable efforts shall be made to place a child
22 and the child's siblings in the same foster care placement or adoptive
23 placement, unless such placement is contrary to the safety or well-being
24 of any of the siblings. This requirement applies even if the custody
25 orders of the siblings are made at separate times and even if the
26 children have no preexisting relationship.

27 (b) If the siblings are not placed together in a joint-sibling
28 placement, the Department of Health and Human Services shall provide the
29 siblings and the court with the reasons why a joint-sibling placement
30 would be contrary to the safety or well-being of any of the siblings.

31 (2) When siblings are not placed together in a joint-sibling

1 placement, the department shall make a reasonable effort to provide for
2 frequent sibling visitation or ongoing interaction between the child and
3 the child's siblings unless the department provides the siblings and the
4 court with reasons why such sibling visitation or ongoing interaction
5 would be contrary to the safety or well-being of any of the siblings. The
6 court shall determine the type and frequency of sibling visitation or
7 ongoing interaction to be implemented by the department. The court shall
8 make a determination as to whether reasonable efforts have been made by
9 the department to facilitate sibling placement and sibling visitation or
10 other ongoing interaction and whether such placement and visitation or
11 other ongoing interaction is contrary to the safety or well-being of any
12 of the siblings.

13 (3) The department shall file a written sibling placement report as
14 required by subsection (3) of section 43-285. Such a report shall include
15 the reasonable efforts of the department to locate the child's siblings
16 and, if a joint-sibling placement is made, whether such placement
17 continues to be consistent with the safety and well-being of the
18 children. If joint-sibling placement is not possible, the report shall
19 include the reasons why a joint-sibling placement is and continues to be
20 contrary to the safety or well-being of any of the siblings, the
21 department's continuing reasonable efforts to place a child with a
22 sibling in the same foster care or adoptive placement, and the
23 department's continuing reasonable efforts to facilitate sibling
24 visitation.

25 (4) Parties to the case, including a child's sibling, may file a
26 motion for joint-sibling placement, sibling visitation, or ongoing
27 interaction between siblings.

28 (5) ~~(4)~~ The court shall periodically review and evaluate the
29 effectiveness and appropriateness of the joint-sibling placement, sibling
30 visitation, or ongoing interaction between siblings.

31 (6) ~~(5)~~ If an order is entered for termination of parental rights of

1 siblings who are subject to this section, unless the court has suspended
2 or terminated joint-sibling placement, sibling visitation, or ongoing
3 interaction between siblings, the department shall make reasonable
4 efforts to make a joint-sibling placement or do all of the following to
5 facilitate frequent sibling visitation or ongoing interaction between the
6 child and the child's siblings when the child is adopted or enters a
7 permanent placement: (a) Include in the training provided to prospective
8 adoptive parents information regarding the importance of sibling
9 relationships to an adopted child and counseling methods for maintaining
10 sibling relationships; (b) provide prospective adoptive parents with
11 information regarding the child's siblings; and (c) encourage prospective
12 adoptive parents to plan for facilitating post-adoption contact between
13 the child and the child's siblings.

14 (7) ~~(6)~~ Any information regarding court-ordered or authorized joint-
15 sibling placement, sibling visitation, or ongoing interaction between
16 siblings shall be provided by the department to the parent or parents if
17 parental rights have not been terminated unless the court determines that
18 doing so would be contrary to the safety or well-being of the child and
19 to the foster parent, relative caretaker, guardian, prospective adoptive
20 parent, and child as soon as reasonably possible following the entry of
21 the court order or authorization as necessary to facilitate the sibling
22 time.

23 (8) ~~(7)~~ For purposes relative to the administration of the federal
24 foster care program and the state plans pursuant to Title IV-B and Title
25 IV-E of the federal Social Security Act, as such act existed on January
26 1, 2015, the term sibling means an individual considered to be a sibling
27 under Nebraska law or an individual who would have been considered a
28 sibling but for a termination of parental rights or other disruption of
29 parental rights such as death of a parent.

30 (9) A sibling of a child under the jurisdiction of the court shall
31 have the right to intervene at any point in the proceedings for the

1 limited purpose of seeking joint-sibling placement, sibling visitation,
2 or ongoing interaction with their sibling.

3 (10) This section shall not be construed to subordinate the rights
4 of foster or adoptive parents of a child to the rights of the parents of
5 a sibling of that child or to subordinate the rights of an adoptive,
6 foster, or biological parent to the rights of a child seeking sibling
7 placement or visitation.

8 Sec. 4. Section 43-4318, Revised Statutes Supplement, 2017, is
9 amended to read:

10 43-4318 (1) The office shall investigate:

11 (a) Allegations or incidents of possible misconduct, misfeasance,
12 malfeasance, or violations of statutes or of rules or regulations of:

13 (i) The department by an employee of or person under contract with
14 the department, a private agency, a licensed child care facility, a
15 foster parent, or any other provider of child welfare services or which
16 may provide a basis for discipline pursuant to the Uniform Credentialing
17 Act;

18 (ii) Subject to subsection (3) ~~(2)~~ of this section, the juvenile
19 services division by an employee of or person under contract with the
20 juvenile services division, a private agency, a licensed facility, a
21 foster parent, or any other provider of juvenile justice services;

22 (iii) The commission by an employee of or person under contract with
23 the commission related to programs and services supported by the Nebraska
24 County Juvenile Services Plan Act, the Community-based Juvenile Services
25 Aid Program, juvenile pretrial diversion programs, or inspections of
26 juvenile facilities; and

27 (iv) A juvenile detention facility and staff secure juvenile
28 facility by an employee of or person under contract with such facilities;

29 (b) Death or serious injury in foster homes, private agencies, child
30 care facilities, juvenile detention facilities, staff secure juvenile
31 facilities, and other programs and facilities licensed by or under

1 contract with the department or the juvenile services division when the
2 office, upon review, determines the death or serious injury did not occur
3 by chance; and

4 (c) Death or serious injury in any case in which services are
5 provided by the department or the juvenile services division to a child
6 or his or her parents or any case involving an investigation under the
7 Child Protection and Family Safety Act, which case has been open for one
8 year or less and upon review determines the death or serious injury did
9 not occur by chance.

10 (2) The department, the juvenile services division, each juvenile
11 detention facility, and each staff secure juvenile facility shall report
12 to the office (a) all cases of death or serious injury of a child in a
13 foster home, private agency, child care facility or program, or other
14 program or facility licensed by the department or inspected through the
15 commission to the Inspector General as soon as reasonably possible after
16 the department or the Office of Probation Administration learns of such
17 death or serious injury and (b) all allegations of sexual abuse of a
18 state ward, juvenile on probation, juvenile in a detention facility, and
19 juvenile in a residential child-caring agency. For purposes of this
20 subsection, serious injury means an injury or illness caused by suspected
21 abuse, neglect, or maltreatment which leaves a child in critical or
22 serious condition.

23 (3) ~~(2)~~ With respect to any investigation conducted by the Inspector
24 General pursuant to subdivision (1)(a) of this section that involves
25 possible misconduct by an employee of the juvenile services division, the
26 Inspector General shall immediately notify the probation administrator
27 and provide the information pertaining to potential personnel matters to
28 the Office of Probation Administration.

29 (4) ~~(3)~~ Any investigation conducted by the Inspector General shall
30 be independent of and separate from an investigation pursuant to the
31 Child Protection and Family Safety Act. The Inspector General and his or

1 her staff are subject to the reporting requirements of the Child
2 Protection and Family Safety Act.

3 (5) ~~(4)~~ Notwithstanding the fact that a criminal investigation, a
4 criminal prosecution, or both are in progress, all law enforcement
5 agencies and prosecuting attorneys shall cooperate with any investigation
6 conducted by the Inspector General and shall, immediately upon request by
7 the Inspector General, provide the Inspector General with copies of all
8 law enforcement reports which are relevant to the Inspector General's
9 investigation. All law enforcement reports which have been provided to
10 the Inspector General pursuant to this section are not public records for
11 purposes of sections 84-712 to 84-712.09 and shall not be subject to
12 discovery by any other person or entity. Except to the extent that
13 disclosure of information is otherwise provided for in the Office of
14 Inspector General of Nebraska Child Welfare Act, the Inspector General
15 shall maintain the confidentiality of all law enforcement reports
16 received pursuant to its request under this section. Law enforcement
17 agencies and prosecuting attorneys shall, when requested by the Inspector
18 General, collaborate with the Inspector General regarding all other
19 information relevant to the Inspector General's investigation. If the
20 Inspector General in conjunction with the Public Counsel determines it
21 appropriate, the Inspector General may, when requested to do so by a law
22 enforcement agency or prosecuting attorney, suspend an investigation by
23 the office until a criminal investigation or prosecution is completed or
24 has proceeded to a point that, in the judgment of the Inspector General,
25 reinstatement of the Inspector General's investigation will not impede or
26 infringe upon the criminal investigation or prosecution. Under no
27 circumstance shall the Inspector General interview any minor who has
28 already been interviewed by a law enforcement agency, personnel of the
29 Division of Children and Family Services of the department, or staff of a
30 child advocacy center in connection with a relevant ongoing investigation
31 of a law enforcement agency.

2 amended to read:

3 43-4406 On or before ~~September 15, 2012,~~ and each September 15
4 ~~thereafter~~, the department shall report electronically to the Health and
5 Human Services Committee of the Legislature the following information
6 regarding child welfare services, with respect to children served by any
7 lead agency or the pilot project and children served by the department:

8 (1) The percentage of children served and the allocation of the
9 child welfare budget, categorized by service area and by lead agency or
10 the pilot project, including:

11 (a) The percentage of children served, by service area and the
12 corresponding budget allocation; and

13 (b) The percentage of children served who are wards of the state and
14 the corresponding budget allocation;

15 (2) The number of siblings in out-of-home care placed with siblings
16 as of the June 30th immediately preceding the date of the report,
17 categorized by service area and by lead agency or the pilot project;

18 (3) The number of waivers granted under subsection (2) of section
19 71-1904;

20 (4) An update of the information in the report of the Children's
21 Behavioral Health Task Force pursuant to sections 43-4001 to 43-4003,
22 including:

23 (a) The number of children receiving mental health and substance
24 abuse services annually by the Division of Behavioral Health of the
25 department;

26 (b) The number of children receiving behavioral health services
27 annually at the Hastings Regional Center;

28 (c) The number of state wards receiving behavioral health services

21 children on his or her caseload;

22 (g) Monthly face-to-face contacts between each case manager and the

25 quarter;

26 (i) Case documentation of monthly consecutive parent contacts per
27 quarter;

28 (j) Case documentation of monthly consecutive child contacts with
