- 5 (1) A plea agreement means that as a result of a discussion between
- 6 the defense counsel and the prosecuting attorney:
- 7 (a) A charge is to be dismissed or reduced; or
- 8 (b) A defendant, if he or she pleads guilty to a charge, may receive
- 9 less than the maximum penalty permitted by law; and
- 10 (2)(a) Victim means a person who $_{7}$ has had a personal confrontation
- 11 with an offender as a result of a homicide under sections 28-302 to
- 12 28-306, a first degree sexual assault under section 28-319, a first
- 13 degree assault under section 28-308, <u>a second degree assault under</u>
- 14 <u>section 28-309</u>, a third degree assault under section 28-310 when the
- 15 <u>victim is an intimate partner as defined in section 28-323, a first</u>
- 16 <u>degree false imprisonment under section 28-314, a first degree sexual</u>
- 17 assault under section 28-319, a sexual assault of a child in the first
- 18 <u>degree under section 28-319.01</u>, a second or third degree sexual assault
- 19 <u>under section 28-320,</u> a sexual assault of a child in the second or third
- 20 degree under section 28-320.01, domestic assault in the first, second, or
- 21 third degree under section 28-323, a sexual assault of a child in the
- 22 first degree under section 28-319.01, a second degree assault under
- 23 section 28-309, a first degree false imprisonment under section 28-314, a
- 24 second degree sexual assault under section 28-320, or a robbery under
- 25 section 28-324. Victim , has had a personal confrontation with the
- 26 offender and also includes a person who has suffered serious bodily
- 27 injury as defined in section 28-109 as a result of a motor vehicle
- 28 accident when the driver was charged with a violation of section 60-6,196
- 29 or 60-6,197 or with a violation of a city or village ordinance enacted in
- 30 conformance with either section.
- 31 (b) In the case of a homicide, victim means the nearest surviving

- 1 relative under the law as provided by section 30-2303 but does not
- 2 include the alleged perpetrator of the homicide.
- 3 (c) In the case of a violation of section 28-813.01, 28-1463.03,
- 4 28-1463.04, or 28-1463.05, victim means a person who was a child as
- 5 defined in section 28-1463.02 and a participant or portrayed observer in
- 6 the visual depiction of sexually explicit conduct which is the subject of
- 7 the violation and who has been identified and can be reasonably notified.
- 8 (d) In the case of a sexual assault of a child, a possession offense
- 9 of a visual depiction of sexually explicit conduct, or a distribution
- 10 offense of a visual depiction of sexually explicit conduct, victim means
- 11 the child victim and the parents, guardians, or duly appointed legal
- 12 representative of the child victim but does not include the alleged
- 13 perpetrator of the crime.
