- 1 A BILL FOR AN ACT relating to the Dentistry Practice Act; to amend sections 38-1101, 38-1102, 38-1107, 38-1116, 38-1119, 38-1121, 2 3 38-1130, 38-1131, 38-1132, 38-1135, and 38-1136, Reissue Revised Statutes of Nebraska; to define and redefine terms; to change 4 provisions relating to dental assistants and licensed dental 5 hygienists; to provide for licensed dental assistants, expanded 6 function dental assistants, and expanded function dental hygienists; 7 8 to provide powers and duties; to harmonize provisions; to provide an 9 operative date; and to repeal the original sections.

- 5 supervision of a licensed dentist or physician if such service is not
- 6 advertised by any name whatever as an aid or inducement to secure dental
- 7 patronage, and no person shall advertise that he or she has, leases,
- 8 owns, or operates a roentgen or X-ray machine for the purpose of making
- 9 dental radiograms of the human teeth or tissues or the oral cavity or
- 10 administering treatment thereto for any disease thereof;

- 26 <u>interim therapeutic restoration technique;</u>
- 27 (v) Upon completion of education and testing approved by the board,
- 28 writing prescriptions for mouth rinses and fluoride products that help

- 30 (vi) Upon completion of education and testing approved by the board,

1 (b) Authorization shall be granted by the department under this 2 subsection upon (i) filing an application with the department, (ii) 3 providing evidence of current licensure and professional liability insurance coverage, and (iii) providing evidence of three thousand hours 4 of clinical experience. Authorization may be limited by the department as 5 necessary to protect the public health and safety upon good cause shown 6 and may be renewed in connection with renewal of the <u>licensed</u> dental 7 8 hygienist's license.

- 9 (c) A licensed dental hygienist performing dental hygiene functions as authorized under this subsection shall (i) report on a form developed 10 and provided by the department authorized functions performed by him or 11 her to the department and (ii) advise the patient or recipient of 12 13 services or his or her authorized representative that such services are preventive in nature and do not constitute a comprehensive dental 14 diagnosis and care. 15
