- 1 Section 1. Section 24-201.01, Reissue Revised Statutes of Nebraska,
- 2 is amended to read:
- 3 24-201.01 On July 1, 2014, the salary of the Chief Justice and the
- 4 judges of the Supreme Court shall be one hundred sixty thousand five
- 5 hundred forty dollars and twenty-five cents. On July 1, 2015, the salary
- 6 of the Chief Justice and the judges of the Supreme Court shall be one
- 7 hundred sixty-six thousand one hundred fifty-nine dollars and sixteen
- 8 cents. On July 1, 2016, the salary of the Chief Justice and the judges of
- 9 the Supreme Court shall be one hundred seventy-one thousand nine hundred
- 10 seventy-four dollars and seventy-three cents. On July 1, 2017, the salary
- 11 of the Chief Justice and the judges of the Supreme Court shall be one
- 12 <u>hundred seventy-three thousand six hundred ninety-three dollars and</u>
- 13 <u>ninety-seven cents. On January 1, 2019, the salary of the Chief Justice</u>
- 14 and the judges of the Supreme Court shall be one hundred seventy-six
- 15 thousand two hundred ninety-nine dollars and thirty-eight cents.
- 16 The Chief Justice and the judges of the Supreme Court shall hold no
- 17 other public office of profit or trust during their terms of office nor
- 18 accept any public appointment or employment under the authority of the
- 19 government of the United States for which they receive compensation for
- 20 their services. Such salaries shall be payable in equal monthly
- 21 installments.
- 22 Sec. 2. This act becomes operative on July 1, 2017.
- 23 Sec. 3. Original section 24-201.01, Reissue Revised Statutes of
- 24 Nebraska, is repealed.
- 25 Sec. 4. Since an emergency exists, this act takes effect when
- 26 passed and approved according to law.
