- 2 in carrying out the provisions of Legislative Bill 647, One Hundred

- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated (1) \$14,683 from the
- 2 General Fund for FY2017-18 and (2) \$26,082 from the General Fund for
- 3 FY2018-19 to the Supreme Court, for Program 3, to aid in carrying out the
- 4 provisions of Legislative Bill 647, One Hundred Fifth Legislature, First
- 5 Session, 2017.
- 6 Total expenditures for permanent and temporary salaries and per
- 7 diems from funds appropriated in this section shall not exceed \$12,035
- 8 for FY2017-18 or \$21,154 for FY2018-19.
- 9 Sec. 2. There is hereby appropriated (1) \$12,062 from the General
- 10 Fund for FY2017-18 and (2) \$21,437 from the General Fund for FY2018-19 to
- 11 <u>the Supreme Court, for Program 4, to aid in carrying out the provisions</u>
- 12 <u>of Legislative Bill 647, One Hundred Fifth Legislature, First Session,</u>
- 13 2017.
- 14 Total expenditures for permanent and temporary salaries and per
- 15 diems from funds appropriated in this section shall not exceed \$9,800 for
- 16 FY2017-18 or \$17,225 for FY2018-19.
- 17 Sec. 3. There is hereby appropriated (1) \$131,773 from the General
- 18 Fund for FY2017-18 and (2) \$234,241 from the General Fund for FY2018-19
- 19 to the Supreme Court, for Program 6, to aid in carrying out the
- 20 provisions of Legislative Bill 647, One Hundred Fifth Legislature, First
- 21 <u>Session</u>, 2017.
- 22 Total expenditures for permanent and temporary salaries and per
- 23 diems from funds appropriated in this section shall not exceed \$106,550
- 24 <u>for FY2017-18 or \$187,285 for FY2018-19.</u>
- 25 Sec. 4. There is hereby appropriated (1) \$111,543 from the General
- 26 Fund for FY2017-18 and (2) \$198,330 from the General Fund for FY2018-19
- 27 <u>to the Supreme Court, for Program 7, to aid in carrying out the</u>
- 28 provisions of Legislative Bill 647, One Hundred Fifth Legislature, First
- 29 <u>Session</u>, 2017.
- 30 <u>Total expenditures for permanent and temporary salaries and per</u>
- 31 diems from funds appropriated in this section shall not exceed \$89,744

- 1 <u>for FY2017-18 or \$157,746 for FY2018-19.</u>
- 2 Sec. 5. There is hereby appropriated (1) \$11,294 from the
- 3 Compensation Court Cash Fund for FY2017-18 and (2) \$22,455 from the
- 4 Compensation Court Cash Fund for FY2018-19 to the Nebraska Workers'
- 5 <u>Compensation Court, for Program 526, to aid in carrying out the</u>
- 6 provisions of Legislative Bill 647, One Hundred Fifth Legislature, First
- 7 <u>Session</u>, 2017.
- 8 Total expenditures for permanent and temporary salaries and per
- 9 <u>diems from funds appropriated in this section shall not exceed \$11,132</u>
- 10 for FY2017-18 or \$19,567 for FY2018-19.
- 11 Sec. 6. This act becomes operative on July 1, 2017.
- 12 Sec. 7. Since an emergency exists, this act takes effect when
- 13 passed and approved according to law.
