- A BILL FOR AN ACT relating to the County Highway and City Street

 Superintendents Act; to amend sections 39-2308, 39-2308.01, and
- 3 39-2308.03, Reissue Revised Statutes of Nebraska; to change
- 4 provisions relating to Class A and Class B licenses for county
- 5 highway superintendents and city street superintendents; to provide
- an operative date; and to repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 39-2308, Reissue Revised Statutes of Nebraska, is

- 3 39-2308 Any person satisfactorily completing the examination
- 4 required by section 39-2307 or exempt from such examination under the
- 5 provisions of subsection (2) of section 39-2306 shall be issued a Class B
- 6 license as a county highway or city street superintendent. Such license
- 7 shall be valid for a period of three years one year and shall be
- 8 renewable upon the payment of a an annual fee of thirty ten dollars. If
- 9 the holder of a Class B license that is up for renewal also holds a Class
- 10 A license that is not then up for renewal, the renewal of the Class B
- 11 license shall be extended to coincide with the three-year renewal cycle
- 12 of the Class A license. Any person holding a license on January 1, 2004,
- 13 shall be deemed to be holding a Class B license under this section.
- 14 Sec. 2. Section 39-2308.01, Reissue Revised Statutes of Nebraska, is

- 16 39-2308.01 Any person holding a Class B license issued pursuant to
- 17 section 39-2308 may apply to the board of examiners for a Class A license
- 18 upon forms prescribed and furnished by the board upon submitting evidence
- 19 that (1) he or she has been employed and appointed by one or more county
- 20 or counties or municipality or municipalities as a county highway or city
- 21 street superintendent at least half-time for at least two years within
- 22 the past six years or (2) he or she has at least four years' experience
- 23 in work comparable to street or highway superintending, on at least a
- 24 <u>half-time basis, within the past eight years</u>. Such application shall be
- 25 accompanied by a fee of seventy-five dollars. A Class A license shall be
- 26 valid for a period of three years and shall be renewable for three years
- 27 as provided in section 39-2308.02 upon payment of a fee of fifty dollars.

- 2 additional license. The holder of a city street superintendent's license
- 3 shall be entitled to hold a county highway superintendent's license of
- 4 the same or a lower level upon payment of the application fee for that
- 5 additional license. A second license shall be placed on the same three-
- 6 year renewal cycle as the license holder's initial license.
