- 1 A BILL FOR AN ACT relating to the Local Government Miscellaneous
- 2 Expenditure Act; to amend section 13-2203, Reissue Revised Statutes
- of Nebraska; to change the expenditure limit for a recognition
- 4 dinner as prescribed; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 13-2203, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 13-2203 In addition to other expenditures authorized by law, each
- 4 governing body may approve:
- 5 (1)(a) The expenditure of public funds for the payment or
- 6 reimbursement of actual and necessary expenses incurred by elected and
- 7 appointed officials, employees, or volunteers at educational workshops,
- 8 conferences, training programs, official functions, hearings, or
- 9 meetings, whether incurred within or outside the boundaries of the local
- 10 government, if the governing body gave prior approval for participation
- 11 or attendance at the event and for payment or reimbursement either by the
- 12 formal adoption of a uniform policy or by a formal vote of the governing
- 13 body. Authorized expenses may include:
- (i) Registration costs, tuition costs, fees, or charges;
- 15 (ii) Mileage at the rate allowed by section 81-1176 or actual travel
- 16 expense if travel is authorized by commercial or charter means; and
- 17 (iii) Meals and lodging at a rate not exceeding the applicable
- 18 federal rate unless a fully itemized claim is submitted substantiating
- 19 the costs actually incurred in excess of such rate and such additional
- 20 expenses are expressly approved by the governing body; and
- 21 (b) Authorized expenditures shall not include expenditures for meals
- 22 of paid members of a governing body provided while such members are
- 23 attending a public meeting of the governing body unless such meeting is a
- 24 joint public meeting with one or more other governing bodies;
- 25 (2) The expenditure of public funds for:
- 26 (a) Nonalcoholic beverages provided to individuals attending public
- 27 meetings of the governing body; and
- 28 (b) Nonalcoholic beverages and meals:
- 29 (i) Provided for any individuals while performing or immediately
- 30 after performing relief, assistance, or support activities in emergency
- 31 situations, including, but not limited to, tornado, severe storm, fire,

- 1 or accident;
- 2 (ii) Provided for any volunteers during or immediately following
- 3 their participation in any activity approved by the governing body,
- 4 including, but not limited to, mowing parks, picking up litter, removing
- 5 graffiti, or snow removal; or
- 6 (iii) Provided at one recognition dinner each year held for elected
- 7 and appointed officials, employees, or volunteers of the local
- 8 government. The maximum cost per person for such dinner shall be
- 9 established by formal action of the governing body, but shall not exceed
- 10 fifty twenty-five dollars. An annual recognition dinner may be held
- 11 separately for employees of each department or separately for volunteers,
- or any of them in combination, if authorized by the governing body; and
- 13 (3) The expenditure of public funds for plagues, certificates of
- 14 achievement, or items of value awarded to elected or appointed officials,
- 15 employees, or volunteers, including persons serving on local government
- 16 boards or commissions. Before making any such expenditure, the governing
- 17 body shall, by official action after a public hearing, establish a
- 18 uniform policy which sets a dollar limit on the value of any plaque,
- 19 certificate of achievement, or item of value to be awarded. Such policy,
- 20 following its initial adoption, shall not be amended or altered more than
- 21 once in any twelve-month period.
