- 2 Revised Statutes Cumulative Supplement, 2016; to change provisions
- 3 relating to experience requirements for issuance of a permit; and to
- 4 repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 1-136.02, Revised Statutes Cumulative Supplement,

- 2 2016, is amended to read:
- 3 1-136.02 (1) The board shall issue a permit under subdivision (1)(a)
- 4 of section 1-136 to a holder of a certificate as a certified public
- 5 accountant when such holder has had:
- 6 (a) Two years of accounting experience satisfactory to the board, in
- 7 any state or foreign country, in employment as an accountant in a firm,
- 8 proprietorship, partnership, corporation, limited liability company, or
- 9 other business entity authorized in any state to engage in the practice
- 10 of public accountancy under the supervision of an active certified public
- 11 accountant who is the holder of a permit issued under subdivision (1)(a)
- of section 1-136 or the equivalent issued by another state;—or
- 13 (b) Except as provided in subdivision (c) of this subsection, three
- 14 Three years of accounting experience satisfactory to the board, in any
- 15 state or foreign country, in employment as (i) an accountant in
- 16 government or business under the supervision of an active certified
- 17 public accountant who is the holder of a permit issued under subdivision
- 18 (1)(a) of section 1-136 or the equivalent issued by another state or (ii)
- 19 faculty at a college or university of recognized standing under the
- 20 supervision of an active certified public accountant who is the holder of
- 21 a permit issued under subdivision (1)(a) of section 1-136 or the
- 22 equivalent issued by another state; or -
- 23 (c) Two years of accounting experience satisfactory to the board in
- 24 <u>employment as an accountant in the office of the Auditor of Public</u>
- 25 Accounts or the Department of Revenue under the supervision of an active
- 26 <u>certified public accountant who is the holder of a permit issued under</u>
- 27 <u>subdivision (1)(a) of section 1-136 or the equivalent issued by another</u>
- 28 state.
- 29 (2) The board shall issue a permit under subdivision (1)(a) of
- 30 section 1-136 to a holder of a reciprocal certificate issued under
- 31 section 1-124 upon a showing that:

1 (a) He or she meets all current requirements in this state for

- 2 issuance of a permit at the time the application is made; and
- 3 (b) At the time of the application for a permit the applicant,
- 4 within the ten years immediately preceding application, meets the
- 5 experience requirement in subdivision $(1)(a)_{+}$ or $(b)_{+}$ or $(c)_{-}$ of this
- 6 section.
