- 1 A BILL FOR AN ACT relating to sexual assault; to amend section 28-318,
- 2 Reissue Revised Statutes of Nebraska; to define a term; to adopt an
- 3 affirmative consent standard; to eliminate obsolete terms; to
- 4 harmonize provisions; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 28-318, Reissue Revised Statutes of Nebraska, is

- 3 28-318 As used in sections 28-317 to 28-322.04, unless the context
- 4 otherwise requires:
- 5 (1) Actor means a person accused of sexual assault;
- 6 (2) Consent means words or overt actions indicating a knowing and
- 7 voluntary agreement, freely given, to engage in sexual contact or sexual
- 8 penetration, except that (a) an expression of lack of consent through
- 9 words or conduct means either there is no consent or consent has been
- 10 withdrawn; (b) a current or previous dating or social or sexual
- 11 <u>relationship by itself, the manner of dress of the person involved with</u>
- 12 <u>the accused, or the victim's use of drugs or alcohol in the conduct at</u>
- 13 <u>issue does not constitute consent; (c) lack of consent may be inferred</u>
- 14 based on all of the surrounding circumstances and must be considered in
- 15 <u>determining whether a person gave consent; (d) consent cannot be given</u>
- 16 under instances of force, fraud, or coercion; and (e) the absence of
- 17 force, fraud, or coercion, by itself, shall not constitute consent;
- 18 (3) (2) Intimate parts means the genital area, groin, inner thighs,
- 19 buttocks, or breasts;
- 20 (4) (3) Past sexual behavior means sexual behavior other than the
- 21 sexual behavior upon which the sexual assault is alleged;
- 22 (5) (4) Serious personal injury means great bodily injury or
- 23 disfigurement, extreme mental anguish or mental trauma, pregnancy,
- 24 disease, or loss or impairment of a sexual or reproductive organ;
- 25 (6) (5) Sexual contact means the intentional touching of the
- 26 victim's sexual or intimate parts or the intentional touching of the
- 27 victim's clothing covering the immediate area of the victim's sexual or
- 28 intimate parts. Sexual contact shall also mean the touching by the victim
- 29 of the actor's sexual or intimate parts or the clothing covering the
- 30 immediate area of the actor's sexual or intimate parts when such touching
- 31 is intentionally caused by the actor. Sexual contact shall include only

- 1 such conduct which can be reasonably construed as being for the purpose
- 2 of sexual arousal or gratification of either party. Sexual contact shall
- 3 also include the touching of a child with the actor's sexual or intimate
- 4 parts on any part of the child's body for purposes of sexual assault of a
- 5 child under sections 28-319.01 and 28-320.01;
- 6 (7) (6) Sexual penetration means sexual intercourse in its ordinary
- 7 meaning, cunnilingus, fellatio, anal intercourse, or any intrusion,
- 8 however slight, of any part of the actor's or victim's body or any object
- 9 manipulated by the actor into the genital or anal openings of the
- 10 victim's body which can be reasonably construed as being for nonmedical
- or nonhealth purposes. Sexual penetration shall not require emission of
- 12 semen; and
- 13 (8) (7) Victim means the person alleging to have been sexually
- 14 assaulted. ÷
- 15 (8) Without consent means:
- 16 (a)(i) The victim was compelled to submit due to the use of force or
- 17 threat of force or coercion, or (ii) the victim expressed a lack of
- 18 consent through words, or (iii) the victim expressed a lack of consent
- 19 through conduct, or (iv) the consent, if any was actually given, was the
- 20 result of the actor's deception as to the identity of the actor or the
- 21 nature or purpose of the act on the part of the actor;
- 22 (b) The victim need only resist, either verbally or physically, so
- 23 as to make the victim's refusal to consent genuine and real and so as to
- 24 reasonably make known to the actor the victim's refusal to consent; and
- 25 (c) A victim need not resist verbally or physically where it would
- 26 be useless or futile to do so; and
- 27 (9) Force or threat of force means (a) the use of physical force
- 28 which overcomes the victim's resistance or (b) the threat of physical
- 29 force, express or implied, against the victim or a third person that
- 30 places the victim in fear of death or in fear of serious personal injury
- 31 to the victim or a third person where the victim reasonably believes that
