Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would create the offense of sexual extortion and change elements and penalties for sexual offenses. This act becomes operative on January 1, 2020.

The Supreme Court estimates a minimal fiscal impact from this bill.

The Board of Parole estimates no significant impact from this bill.

The Department of Correctional Services states that the fiscal impact of this bill is indeterminable.

This bill creates a new criminal offense and also changes provisions of current criminal offenses. Misdemeanor and felony penalties are imposed for violating various provisions of the bill.

Therefore, the bill could potentially increase the number of persons sentenced to prison or county jails. This could increase the incarcerated population and costs to both the state and counties. Any impact is not known at this time.

Both the misdemeanor and felony penalties under this bill also carry the possibility of a fine being imposed. Any fines assessed pursuant to convictions will accrue to the county where the violation occurs to be used for the support of public schools.
