- A BILL FOR AN ACT relating to the Cash Reserve Fund; to amend section
 84-612, Revised Statutes Cumulative Supplement, 2018; to authorize a
 transfer; to repeal the original section; and to declare an
 emergency.
- 5 Be it enacted by the people of the State of Nebraska,

Section 1. Section 84-612, Revised Statutes Cumulative Supplement,
 2018, is amended to read:

84-612 (1) There is hereby created within the state treasury a fund
known as the Cash Reserve Fund which shall be under the direction of the
State Treasurer. The fund shall only be used pursuant to this section.

6 (2) The State Treasurer shall transfer funds from the Cash Reserve 7 Fund to the General Fund upon certification by the Director of 8 Administrative Services that the current cash balance in the General Fund 9 is inadequate to meet current obligations. Such certification shall 10 include the dollar amount to be transferred. Any transfers made pursuant 11 to this subsection shall be reversed upon notification by the Director of 12 Administrative Services that sufficient funds are available.

(3) In addition to receiving transfers from other funds, the Cash
Reserve Fund shall receive federal funds received by the State of
Nebraska for undesignated general government purposes, federal revenue
sharing, or general fiscal relief of the state.

17 (4) The State Treasurer, at the direction of the budget 18 administrator of the budget division of the Department of Administrative 19 Services, shall transfer not to exceed forty million seven hundred 20 fifteen thousand four hundred fifty-nine dollars in total from the Cash 21 Reserve Fund to the Nebraska Capital Construction Fund between July 1, 22 2013, and June 30, 2018.

(5) The State Treasurer shall transfer the following amounts from
the Cash Reserve Fund to the Nebraska Capital Construction Fund on such
dates as directed by the budget administrator of the budget division of
the Department of Administrative Services:

(a) Seven million eight hundred four thousand two hundred ninety-two
dollars on or after June 15, 2016, but before June 30, 2016;

(b) Five million fifty-eight thousand four hundred five dollars on
or after July 1, 2018, but before June 30, 2019, on such dates and in
such amounts as directed by the budget administrator of the budget

1 division of the Department of Administrative Services; and

2 (c) Fifteen million three hundred seventy-eight thousand three
3 hundred nine dollars on or after January 1, 2019, but before June 30,
4 2019, on such dates and in such amounts as directed by the budget
5 administrator of the budget division of the Department of Administrative
6 Services; and -

7 (d) Fifty-four million seven hundred thousand dollars on or after
8 July 1, 2019, but before June 15, 2021, on such dates and in such amounts
9 as directed by the budget administrator of the budget division of the
10 Department of Administrative Services.

(6) The State Treasurer shall transfer seventy-five million two hundred fifteen thousand three hundred thirteen dollars from the Cash Reserve Fund to the Nebraska Capital Construction Fund on or before July 31, 2017, on such date as directed by the budget administrator of the budget division of the Department of Administrative Services.

16 (7) The State Treasurer shall transfer thirty-one million dollars 17 from the Cash Reserve Fund to the General Fund after July 1, 2017, but 18 before July 15, 2017, on such date as directed by the budget 19 administrator of the budget division of the Department of Administrative 20 Services.

(8) The State Treasurer shall transfer thirty-one million dollars from the Cash Reserve Fund to the General Fund after October 1, 2017, but before October 15, 2017, on such date as directed by the budget administrator of the budget division of the Department of Administrative Services.

(9) The State Treasurer shall transfer thirty-one million dollars
from the Cash Reserve Fund to the General Fund after January 1, 2018, but
before January 15, 2018, on such date as directed by the budget
administrator of the budget division of the Department of Administrative
Services.

31 (10) The State Treasurer shall transfer thirty-two million dollars

1 from the Cash Reserve Fund to the General Fund after April 1, 2018, but 2 before April 15, 2018, on such date as directed by the budget 3 administrator of the budget division of the Department of Administrative 4 Services.

5 (11) The State Treasurer shall transfer one hundred million dollars 6 from the Cash Reserve Fund to the General Fund on or before June 30, 7 2018, on such dates and in such amounts as directed by the budget 8 administrator of the budget division of the Department of Administrative 9 Services.

10 (12) The State Treasurer shall transfer forty-eight million dollars 11 from the Cash Reserve Fund to the General Fund after March 1, 2019, but 12 before March 15, 2019, on such date as directed by the budget 13 administrator of the budget division of the Department of Administrative 14 Services.

Sec. 2. Original section 84-612, Revised Statutes CumulativeSupplement, 2018, is repealed.

17 Sec. 3. Since an emergency exists, this act takes effect when 18 passed and approved according to law.
