- 1 A BILL FOR AN ACT relating to the Legislative Performance Audit Act; to
- amend sections 50-1204 and 50-1205.01, Revised Statutes Cumulative
- 3 Supplement, 2018; to adopt updated audit standards; and to repeal
- 4 the original sections.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 50-1204, Revised Statutes Cumulative Supplement,

2 2018, is amended to read:

3 50-1204 (1) The Legislative Performance Audit Committee is hereby established as a special legislative committee to exercise the authority 4 5 and perform the duties provided for in the Legislative Performance Audit Act. The committee shall be composed of the Speaker of the Legislature, 6 the chairperson of the Executive Board of the Legislative Council, the 7 chairperson of the Appropriations Committee of the Legislature, and four 8 9 other members of the Legislature to be chosen by the Executive Board of the Legislative Council. The executive board shall ensure that the 10 Legislative Performance Audit Committee includes adequate geographic 11 representation. The chairperson and vice-chairperson of the Legislative 12 Performance Audit Committee shall be elected by majority vote. For 13 purposes of tax incentive performance audits authorized in section 14 50-1209, the committee shall include as nonvoting members the chairperson 15 16 of the Revenue Committee of the Legislature or his or her designee and 17 one other member of the Revenue Committee, as selected by the Revenue Committee. The Legislative Performance Audit Committee shall be subject 18 to all rules prescribed by the Legislature. The committee shall be 19 reconstituted at the beginning of each Legislature and shall meet as 20 needed. 21

22 (2) The Legislative Auditor shall ensure that performance audit work conducted by the office conforms with performance audit standards 23 24 contained in the Government Auditing Standards (2018 2011 Revision) as required in section 50-1205.01. The office shall be composed of the 25 Legislative Auditor and other employees of the Legislature employed to 26 conduct performance audits. The office shall be the custodian of all 27 records generated by the committee or office except as provided by 28 section 50-1213, subsection (11) of section 77-2711, or subdivision (10) 29 (a) of section 77-27,119. The office shall inform the Legislative Fiscal 30 Analyst of its activities and consult with him or her as needed. The 31
