Summary of purpose and/or changes:

SUMMARY:

LB 1130 would give statutory authority to certain state agencies to collect and share certain data with the Nebraska Statewide Workforce and Education Reporting System (NSWERS) in order to produce the data required under the act.

SECTION BY SECTION SUMMARY:

Sec. 1: Beginning on or before 12/1/22 guarterly wage reports from the Department of Labor shall include: First Middle Last

Name, DOB, Job Title, Pay Rate, Employment start date, employment end date, and job location

Sec. 2: Beginning on or before 12/1/22 the report given in Sec 1 shall also include DOB and state of hire.

Sec. 4: For purposes of the Nebraska Statewide Workforce and Education Reporting System Act, NSWERS means the Nebraska Statewide Workforce and Education Reporting System.

Sec. 5: On or before 12/31/22 Dep of Labor and Department of Health, shall enter into agreement with NSWERS and ensure date collection and transfer under 48-2303.

On or before 12/31/22 DMV shall enter agreement with NSWERS and provide data to

include: Name, DOB, Gender, SSN, address.

On or before 12/31/22 Department of Revenue shall enter agreement with NSWERS and provide date to include: EIN, Name, DOB, SSN, residence status, Employer EIN, Employer name.

On or before 11/1/22 each department listed in Sec 5 shall submit a report to the Legislature describing any statutory changes necessary to carry out the purpose of this act.

Sec 6: NSWERS shall hold confidential all personally identifiable information collected.

Sec 9: Repealer

AM2206: Strikes the original bill in it's entirety. Changes the reporting date from December 1, 2021 to December 1, 2022.
