Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill appropriates \$172,000 to the Crime Commission to be used by the Nebraska Law Enforcement Training Center to enforce provisions relating to the revocation of law officer certification.

The Crime Commission is revising their fiscal note based on clarification they received at the hearing on February 18, 2021. They will hire an instructor at the Training Center to conduct mandated background and de-certification investigations. They estimate \$86,000 for the salary and benefits for this position, plus one-time operating costs in FY22. The agency notes that the bill will need to be changed from appropriating \$172,000 in FY22 only, to appropriating \$86,000 in both FY22 and FY23.
