- 1 A BILL FOR AN ACT relating to the State Electrical Act; to amend section
- 2 81-2103, Reissue Revised Statutes of Nebraska; to change the number
- of members of the State Electrical Board; to change qualifications
- 4 for certain members of the State Electrical Board; and to repeal the

- 6 Be it enacted by the people of the State of Nebraska,

Section 1. Section 81-2103, Reissue Revised Statutes of Nebraska, is

2 amended to read:

3 81-2103 (1) There is hereby established an independent agency to be known as the State Electrical Division which shall be under the 4 5 administrative and operative control of the executive director of such division. The division shall include a nine-member seven-member State 6 Electrical Board appointed by the Governor with the consent of the 7 Legislature. All members of the board shall be residents of the State of 8 9 Nebraska. The board shall direct the efforts of the executive director 10 and set the policy of the division. Two One of such members shall be a journeyman <u>electricians</u>, one of which shall be appointed in accordance 11 with subsection (2) of this section electrician, two one shall be an 12 13 electrical contractors or master electricians, one of which shall be appointed in accordance with subsection (3) of this section contractor or 14 master electrician, one shall be a certified electrical inspector, one 15 shall be a licensed professional electrical engineer, one shall be a 16 17 representative of a public power district or rural electric cooperative in the state, one shall be a representative of the municipal electric 18 19 systems in the state, and one shall be a member of any of such groups. The members of the board shall be appointed for staggered terms of five 20 years. Any vacancy occurring in the membership of the board shall be 21 filled by the Governor for the unexpired term. Each member of the board 22 23 shall serve until a his or her successor is appointed and qualified. The 24 executive director shall be the executive secretary of the board and 25 shall be responsible for all books, records, and transcripts of proceedings of the board. 26

- 27 (2) One of the two journeyman electricians shall be affiliated with 28 a nonprofit labor organization for electrical workers and selected from a 29 list of electricians recommended by such organization.
- 30 (3) One of the two electrical contractors or master electricians
 31 shall be affiliated with a nonprofit labor organization for electrical
