- A BILL FOR AN ACT relating to agriculture; to amend sections 2-2634 and 81-2,162.06, Revised Statutes Cumulative Supplement, 2020; to change the amount of a pesticide registration fee credit under the Pesticide Act; to change provisions relating to fixing the rate of an inspection fee under the Nebraska Commercial Fertilizer and Soil Conditioner Act; to harmonize provisions; and to repeal the original sections.
- 8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 2-2634, Revised Statutes Cumulative Supplement,

- 2 2020, is amended to read:
- 3 2-2634 (1) As a condition to registration or renewal of registration
- 4 as required by sections 2-2628 to 2-2633, an applicant shall pay to the
- 5 department a fee of one hundred sixty dollars for each pesticide to be
- 6 registered, except that the fee may be increased or decreased by rules
- 7 and regulations adopted and promulgated pursuant to the Pesticide Act. In
- 8 no event shall such fee exceed two hundred ten dollars for each pesticide
- 9 to be registered.
- 10 (2) All fees collected under subsection (1) of this section shall be
- 11 remitted to the State Treasurer for credit as follows:
- 12 (a) Thirty dollars of such fee to the Noxious Weed Cash Fund as
- 13 provided in section 2-958;
- 14 (b) Fifty Sixty dollars of such fee to the Buffer Strip Incentive
- 15 Fund as provided in section 2-5106;
- 16 (c) Fifty-five dollars of such fee to the Natural Resources Water
- 17 Quality Fund; and
- 18 (d) The remainder of such fee to the Pesticide Administrative Cash
- 19 Fund.
- 20 (3) If a person fails to apply for renewal of registration before
- 21 January 1 of any year, such person, as a condition to renewal, shall pay
- 22 a late registration fee equal to twenty-five percent of the fee due and
- 23 owing per month, not to exceed one hundred percent, for each product to
- 24 be renewed in addition to the renewal fee. The purpose of the late
- 25 registration fee is to cover the administrative costs associated with
- 26 collecting fees, and all money collected as a late registration fee shall
- 27 be remitted to the State Treasurer for credit to the Pesticide
- 28 Administrative Cash Fund.
- 29 Sec. 2. Section 81-2,162.06, Revised Statutes Cumulative Supplement,
- 30 2020, is amended to read:
- 31 81-2,162.06 (1) There shall be paid to the director, for all

- 1 commercial fertilizers and soil conditioners distributed in this state to
- 2 the ultimate user, except custom-blended products, an inspection fee at
- 3 the rate fixed by the director but not exceeding <u>fifteen</u> ten cents per
- 4 ton. The fee shall be paid by the person distributing the product to the
- 5 ultimate user.
- 6 (2) The director may increase or decrease the inspection fee each
- 7 July 1, but such fee shall not exceed the maximum rate established in
- 8 subsection (1) of this section. The director shall determine the fee
- 9 based on the estimated annual revenue and fiscal year-end fund balance
- 10 determined as follows:
- 11 <u>(a) The estimated annual revenue shall not be greater than one</u>
- 12 <u>hundred seven percent of the program cash fund appropriations allocated</u>
- 13 for the Nebraska Commercial Fertilizer and Soil Conditioner Act; and
- 14 (b) The estimated fiscal year-end cash fund balance shall not be
- 15 greater than seventeen percent of the program cash fund appropriations
- 16 allocated for the Nebraska Commercial Fertilizer and Soil Conditioner
- 17 Act.
- 18 (3) (2) Payment of the inspection fee shall be evidenced by a
- 19 statement made with documents showing that fees corresponding to the
- 20 tonnage were received by the director.
- 21 (4) (3) Every person who distributes commercial fertilizer or soil
- 22 conditioners to the ultimate user in this state shall file, not later
- 23 than the last day of January and July of each year, a semiannual tonnage
- 24 report on forms provided by the department setting forth the number of
- 25 net tons of commercial fertilizer and soil conditioners distributed in
- 26 this state during the preceding six-month period, which report shall
- 27 cover the periods from July 1 to December 31 and January 1 to June 30,
- 28 and such other information as the director shall deem necessary. All
- 29 persons required to be licensed pursuant to the Nebraska Commercial
- 30 Fertilizer and Soil Conditioner Act shall file such report regardless of
- 31 whether any inspection fee is due. Upon filing the report, such person

- 1 shall pay the inspection fee at the rate prescribed pursuant to
- 2 subsection (1) of this section. The minimum inspection fee required
- 3 pursuant to this section shall be five dollars, and no inspection fee
- 4 shall be paid more than once for any one product.
- 5 (5) (4) If a person fails to report and pay the fee required by
- 6 subsection (4) (3) of this section by January 31 and July 31, the fee
- 7 shall be considered delinquent and the person owing the fee shall pay an
- 8 additional administrative fee of twenty-five percent of the delinquent
- 9 amount for each month it remains unpaid, not to exceed one hundred
- 10 percent of the original amount due. The department may waive the
- 11 additional administrative fee based upon the existence and extent of any
- 12 mitigating circumstances that have resulted in the late payment of such
- 13 fee. The purpose of the additional administrative fee is to cover the
- 14 administrative costs associated with collecting fees and all money
- 15 collected as an additional administrative fee shall be remitted to the
- 16 State Treasurer for credit to the Fertilizers and Soil Conditioners
- 17 Administrative Fund. Failure to make an accurate statement of tonnage or
- 18 to pay the inspection fee or comply as provided in this subsection shall
- 19 constitute sufficient cause for the cancellation of all product
- 20 registrations, licenses, or both on file for such person.
- 21 (6) (5) No information furnished to the department under this
- 22 section shall be disclosed in such a way as to reveal the operation of
- 23 any person.
