- 4 the provisions of Legislative Bill 920, One Hundred Seventh Legislature,
- 5 Second Session, 2022.
- 6 Total expenditures for permanent and temporary salaries and per
- 7 diems from funds appropriated in this section shall not exceed \$1,370,100
- 8 <u>for FY2022-23 or \$1,370,100 for FY2023-24.</u>
- 9 Sec. 2. There is hereby appropriated (1) \$2,539,529 from the
- 10 General Fund for FY2022-23 and (2) \$2,499,529 from the General Fund for
