- 1 A BILL FOR AN ACT relating to state government; to provide for
- 2 improvement of government services of state agencies as prescribed;
- and to declare an emergency.
- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) The Department of Administrative Services shall, in
- 2 compliance with all statutes on contracts, contract with an entity to
- 3 assist the state with significantly improving government services of
- 4 state agencies listed in section 2 of this act for a period of two years
- 5 starting on July 1, 2023, and ending on June 30, 2025. The contract shall
- 6 include the option to renew for two additional one-year periods upon
- 7 mutual agreement of the parties. The state shall reserve the right to
- 8 extend the period of this contract beyond the termination date if
- 9 mutually agreeable to the parties. The entity shall recommend and support
- 10 strategies that reduce costs while improving quality, with a target of
- 11 <u>twenty-five percent improvement overall across all programs during the</u>
- 12 <u>contract period. Specifically, the entity shall assist with:</u>
- 13 (a) Developing statewide measures and associated performance targets
- 14 for improving program outcomes and decreasing overall costs;
- (b) Developing criteria, rationale, and plans to sequentially review
- 16 and improve programs;
- 17 <u>(c) Identifying, recommending, and implementing program changes that</u>
- 18 improve effectiveness and efficiency to accomplish performance targets;
- 19 <u>(d) Ensuring fidelity and integrity in the application of</u>
- 20 <u>improvement principles and techniques;</u>
- 21 <u>(e) Identifying where and how to repurpose resources for highest</u>
- 22 <u>impact; and</u>
- 23 (f) Supporting training and staff development that builds
- 24 improvement capacity and systems management expertise including
- 25 performance measurement.
- 26 (2) The department shall electronically provide the results of the
- 27 improvement to the Legislative Council no later than July 1, 2025.
