

LEGISLATIVE BILL 207

AN ACT relating to driver education; to amend sections 60-409, 60-409.02, 60-409.12, and 72-1237.01, Reissue Revised Statutes of Nebraska, 1943; to increase the per pupil state payment; to increase and reallocate drivers' license and permit fees; to eliminate a fund; to provide an operative date; to repeal the original sections, and also section 60-409.01, Reissue Revised Statutes of Nebraska, 1943.

Be it enacted by the people of the State of Nebraska,

Section 1. That section 60-409, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

60-409. The applications for operators' licenses, school permits, or learners' permits shall be filed with the county treasurer who is required to transmit the same weekly to the Director of Motor Vehicles. The application shall be accompanied by a fee of seven ten dollars from each successful applicant for an original or renewal operator's license issued under this act; Provided, that the fee for licenses which will be valid for one year or less shall be two three dollars and fifty cents, the fee for licenses which will be valid for more than one year but less than two years shall be four five dollars and fifty cents, and the fee for licenses which will be valid for more than two years but less than three years shall be five eight dollars, and fifty--cents---~~Twenty-five--per--cent~~ One dollar and seventy-five cents of each of the original and renewal fees for operators' licenses, twenty-five cents of each of the fees for school permits, and twenty-five cents of each of the fees for learners' permits shall be credited forthwith to the general fund of the county and shall be included by the county treasurer in his or her report of fees as provided by law. The balance of the original and renewal operator's license fees provided--herein and school or learner's permit fees shall be remitted by the county treasurer to the State Treasurer and fifty--per cent--of--the--original--and--renewal--operator's--license--and school--or--learner's--permit--fee shall be credited to the Driver-Education General Fund. Any money available in the Driver Education Fund on the operative date of this

~~act shall be transferred to the General Fund established by section 60-409.01 and the remainder shall be credited by the State Treasurer to the General Fund.~~

Sec. 2. That section 60-409.02, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

~~60-409.02. Commencing September 1, 1964, and on September 1 of each year thereafter if money is appropriated from the General Fund, the balance of the Driver Education Fund appropriation, after the administration expenses have been deducted, shall be apportioned on September 1 of each year to the public school districts of the state on the basis of the lesser of the actual cost of the driver education program or forty eighty dollars for each student having satisfactorily completed a course of driver education in the immediately preceding twelve-month period as certified by the Commissioner of Education. Such apportionment shall be made on the basis of an application and certification by the local school superintendents to the Commissioner of Education. Any money available for investment shall be invested by the state investment officer pursuant to the provisions of sections 72-1237 to 72-1259. in the event that the funds are insufficient to be apportioned on the basis of the lesser of the cost or forty dollars per student, such funds shall be prorated among the public school districts participating in the driver education program on the basis of the total number of students completing the course in the immediately preceding twelve-month period. Any balance remaining in the Driver Education Fund at the end of the biennium shall be reappropriated.~~

Sec. 3. That section 60-409.12, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

60-409.12. The provisions of sections 60-409.06 to 60-409.13 shall not apply to any person giving driver training lessons under sections 60-409, 60-409.01, 60-409.02, 60-409.03, and 60-409.04.

Sec. 4. That section 72-1237.01, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

Sec. 5. This act shall become operative on July 1, 1981.

Sec. 6. That original sections 60-409, 60-409.02, 60-409.12, and 72-1237.01, Reissue Revised Statutes of Nebraska, 1943, and also section 60-409.01, Reissue Revised Statutes of Nebraska, 1943, are repealed.
