AN ACT relating to retirement; to amend sections 23-2306, 79-1501.01, 81-2014, 81-2016, 81-2033, 84-1307, and 84-1331, Reissue Revised Statutes of Nebraska, and section 23-2331, Revised Statutes Supplement, 1994; to change provisions relating to vesting credit and eligibility; to harmonize provisions; and to repeal the original sections.

Be it enacted by the people of the State of Nebraska,

Section 23-2306, Reissue Revised Statutes of Nebraska, Section 1. is amended to read:

(1) The membership of the retirement system shall be 23-2306. composed of (1) (a) all full-time employees who have been employees for a period of twelve continuous months, except that elected officials shall be eligible for membership on taking office, and (2) (b) all part-time employees who have attained the age of twenty-five and have been employed for a total of twelve months and who exercise the option to join the retirement system. An employee who exercises the option to join the retirement system shall remain in the system until termination or retirement.

(2) Within the first thirty days of employment, a full-time employee may apply to the board for eligibility and vesting credit for years of participation in another Nebraska governmental plan, as defined by section 414(d) of the Internal Revenue Code. During the years of participation in the other Nebraska governmental plan, the employee must have been a full-time employee.

For one year after the effective date of this act, any full-time employee employed on or before the effective date of this act may apply to the board for eligibility and yesting credit for years αf participation in another Nebraska governmental plan, as defined by section 414(d) of the Internal Revenue Code. During the years of participation in the other Nebraska governmental plan, the employee must have been a full-time employee.

Within the first thirty days of employment, employee may apply to the hoard for eligibility and vesting credit for years of participation in another Nebraska governmental plan, as defined by section 414(d) of the Internal Revenue Code. During the years of participation in the other Nebraska governmental plan, the employee must have been a full-time or a part-time employee as described in section 79-1501. Such credit shall not be included as years of service in the benefit calculation.

Sec. 6. For one year after the effective date of this act, any school employee employed on or before the effective date of this act may apply to the board for eligibility and vesting credit for years of participation in another Nebraska governmental plan, as defined by section 414(d) of the Internal Revenue Code. During the years of participation in the other Nebraska governmental plan, the employee must have been a full-time or a part-time employee as described in section 79-1501. Such credit shall not be

included as years of service in the benefit calculation.

to 81-2009 Sec. 8. Section 81-2016, Reissue Revised Statutes of Nebraska, is

amended to read: 81-2016. (1) Every member of the Nebraska State Patrol who was employed by the State of Nebraska as such, on September 7, 1947, and every person employed as a member of such patrol thereafter, shall be a member of

this system.

(2) Within the first thirty days of employment, a member may to the board for eligibility and vesting credit for years of participation in another Nebraska governmental plan, as defined by section 414(d) of the Internal Revenue Code. Such credit shall be used toward the vesting percentage pursuant to subsection (2) of section 812031 but shall not be

included as years of service in the benefit calculation.

Sec. 9. For one year after the effective date of this act, any member employed on or before the effective date of this act may apply to the board for eligibility and vesting credit for years of participation in another Nebraska governmental plan, as defined by section 414(d) of the Internal Revenue Code. Such credit shall be used toward the vesting percentage pursuant to subsection (2) of section 81-2031 but shall not be included as years of service in the benefit calculation.

Sec. 10. Section 81-2033, Reissue Revised Statutes of Nebraska, is

amended to read:

In computing length of service under sections 81-2014 to 81-2033. 81-2036, such service shall include the years of service with the Nebraska State Patrol, permanent force, as established by the law creating the Nebraska State Patrol computed to the nearest one-twelfth year and shall only include such years during which the person was a member of the Nebraska State Patrol Length of service shall also include credit for time Retirement System. served in the armed forces pursuant to section 81-2034. For subsection (2) of section 81-2031 only, service shall also include credit for vesting pursuant to section 81-2016 and section 9 of this act.

Sec. 11. Section 84-1307, Reissue Revised Statutes of Nebraska, is

amended to read:

84-1307. (1) The membership of the retirement system shall be composed of (1) (a) all permanent full-time employees who have been employees for a period of twenty-four continuous months at any time and who have attained the age of thirty and (2) (b) all full-time or part-time employees who have been employees for a total of twelve months, who have attained the age of twenty, and who exercise the option to join the retirement system. An employee who exercises the option to join the retirement system pursuant to this section shall remain in the retirement system until his or her termination or retirement. Membership shall not include part-time or termination or retirement. Membership shall not include part-time or temporary employees except (a) (i) such part-time employees who have been full-time employees but because of age or otherwise have been partially incapacitated and have been placed on a part-time service basis at a part-time rate of pay under rules and regulations of the retirement board, (b) (ii) such part-time employees who are members of the system, and (c) (iii) part-time employees who join the system as provided in subdivision (2) subdivision (1)(b) of this section.

(2) Within the first thirty days of employment, a full-time employee apply to the board for eligibility and vesting credit for years of participation in another Nebraska governmental plan, as defined by section 414(d) of the Internal Revenue Code. During the years of participation in the other Nebraska governmental plan, the employee must have been a full-time

employee.

Sec. 12. For one year after the effective date of this act, any full-time employee employed on or before the effective date of this act may apply to the board for eligibility and vesting credit for years of participation in another Nebraska governmental plan, as defined by section 114(d) of the Internal Purpose Code.
