LB 805 expands the eligibility of persons for admittance to Nebraska's Veterans Homes. The bill changes one of the current criteria allowing a person to apply for admittance if they have been a resident for two years. The bill allows a person to apply who has met all the criteria and whose parents or children have been residents of the state for at least two years.

This change has no fiscal impact for the Department of Health and Human Services because the bill does not require the state to fund additional beds. The change in eligibility may allow different individuals to be admitted to the veterans' homes but will not increase the overall number of admissions.
