Explanation of Estimate:

LB 1000 would have a one-time fiscal impact related to printing publications given to parents and training for judges and mediators, but the increase in expenditures is not estimated to be significant.

Potential long-term fiscal impact; other states that have enacted legislation regarding parenting have required additional court staff to assist in the implementation of parenting plans. Although not necessary at this time, additional court resources may be needed in future years.
