LB 422 would provide that the reasonable fees and costs of an attorney, a guardian ad litem, a physician, and a visitor appointed by the court for the minor may be paid by the estate of the county in the event there is not an estate of the minor. The fiscal impact of this legislation will result in greater potential liability to counties; however, that amount is unknown.
