LB 795 changes provisions related to the Nebraska Telecommunications Universal Service Fund Act.

Section 3 defines Wireless carrier as a telecommunications company providing mobile radio service, radio paging service, or wireless telecommunications service for a fee in Nebraska intrastate commerce.

Section 6 requires the Public Service Commission to establish the Wireless in Nebraska Program to promote the provisions of universal wireless telecommunications service throughout the state by providing assistance from the Nebraska Universal Service Fun to eligible wireless carriers for the construction of cellular sites and wireless communications towers.

The bill's provisions essentially call for a new utilization of aid funds. The total amount of aid is not affected.
