LB 947 amends Nebraska Revised Statutes Section 4-111 regarding verification of lawful presence in the United States.

The bill provides that for purposes of a professional or commercial license a person who is not a citizen of the United States or is a qualified alien under the federal Immigration and Nationality Act and is lawfully present in the United States may submit the following:

- An unexpired employment authorization document issued by the U.S. Dept. of Homeland Security, Form I-766 or I-688B; and
- Documentation issued by the U.S. Dept. of Homeland Security, the U.S. Citizenship and Immigration Services, or any other federal agency, such as the one of the types of Form I-797, demonstrating that such person is described in section 202(c)(2)(B)(i) through (ix) of the federal REAL ID act of 2005, Public Law 109-13, has demonstrated lawful presence pursuant to Nebraska Revised Statutes Section 4-108 and is eligible to obtain such license.

There is no fiscal impact to the state as a result of LB 947.
